I. DISCUSSION

The applicant, Classical Movements, represented by Neeta Helms, requests Special Use Permit (SUP) approval for indoor and outdoor live entertainment and for indoor and outdoor events, which are defined as restaurant and outdoor dining uses in the City's Zoning Ordinance when food is featured as part of the event.

SITE DESCRIPTION

The subject property is an 8,491 square foot lot of record and is developed with a 5,642 square foot commercial building, constructed circa 1785. Open space behind and on the east side of the building measures approximately 3,866 square feet and is landscaped as a garden with patio area. A driveway and parking spaces exist to the east of the building.

A mix of commercial and residential uses surround the applicant's property. Commercial



and residential properties share property lines with 711 Princess Street to the east, and the senior living facility, Sunrise of Old Town, shares property lines to the north and west (Figure 2, Page 4).

BACKGROUND

Classical Movements has organized concert tours, nationally and internationally, for orchestras and choirs since 1992 at 711 Princess Street. In addition, virtual music lessons were recently added to the operation.

City email records indicate that the applicant contacted staff in April and May 2020 inquiring about what they could do in the CD zone as concert performances had largely ceased with the onset of the COVID-19 pandemic in March 2020. We sincerely regret that a staff member did not reply to the business's inquiry at that time.

In November, staff learned of outdoor concerts held since the summer months at 711 Princess Street, when an abutting residential neighbor submitted a notarized complaint to the City regarding noise. The applicant received a warning citation and was informed that Special Use Permit approval was required to conduct outdoor live entertainment. As the next earliest City Council hearing was March 2021, P&Z coordinated with Transportation and Environmental Services (T&ES) to allow for a temporary noise permit option. This was to allow Classical Movements the opportunity to continue to hold up to three already scheduled concerts, concluding at 8 p.m., with

the approval of neighboring property owners prior to the March hearing. The business did not pursue this option, choosing instead to wait until the SUP hearings in March to learn if its SUP request would be approved prior to resuming outdoor concerts.

PROPOSAL

As its primary business function organizing concert tours is severely impacted by the pandemic, the applicant, Classical Movements, represented by Neeta Helms, proposes new uses to augment its business model: indoor and outdoor live entertainment in the form of classical concerts with occasional vocalists; and indoor and outdoor special events, which include food service. The concerts are defined in the Zoning Ordinance as live entertainment given that they would be the primary attraction at the commercial use and admission would be charged. Events with food

service are most closely associated with the Zoning Ordinance restaurant and outdoor dining use definitions, explaining the SUP application request for these uses.

The following outlines the proposals in detail:

Indoor and outdoor live entertainment

Days:	Between one to four concerts a day on Saturdays and Sundays; most days would feature two concerts
Months	Four days a month, primarily between March through August
Hours	10 a.m. to 10 p.m.
Guests:	Up to 56 accommodated with socially-distanced seat spacing
Noise	Unamplified music and announcements; double-paned building windows provide sound proofing for indoor concerts
Trash:	Removed from the property the day of the concert

Indoor and outdoor events*

Weddings	
Days:	Saturdays and Sundays
Months	Four days a month, primarily between March through August
Hours	10 a.m. to 10 p.m.; two to eight hours per event
Guests:	Up to 50
Food service:	Prepared off-site by caterer and warmed at on-site kitchen
Trash:	Removed from the property the day of the event

The garden area where outdoor concerts and events would take place is illustrated in Figures 3-6. Figures 3 and 4 provide a photographic view of the rear garden area and note options for two stage locations. Figure 5 identifies the approximate location of the stage areas in a map aerial view and Figure 6 provides a sample layout for a concert with socially-distanced seating.

<u>PARKING</u>

Section 8-200 (A)(17)(a)(i) requires restaurant applicants to provide a minimum of one and a maximum of three off-street parking spaces for every 1,000 square feet of restaurant space. With 5,642 square feet of indoor space and 450 square feet accounting for outdoor dining, the applicant

is required to provide a minimum of seven and a maximum of 21 off-street parking spaces. Although the application states six off-street parking spaces exist on the property, only two standard spaces, as defined in the Zoning Ordinance, are present at the site. The applicant provides 10 off-street parking spaces (two spaces on-site and eight spaces arranged through parking agreements with nearby commercial businesses), within the range required in the Zoning Ordinance.

ZONING/MASTER PLAN DESIGNATION AND CITY CODE OF ORDINANCES

Use Requirements

The applicant's business and professional office and the private commercial school, providing music lessons, are permitted uses in the CD zone, pursuant to Section 4-502. Section 4-503(A) requires SUP approval for any use with live entertainment. Outdoor dining with over 40 seats requires SUP approval in accordance with Section 11-513(M)(3). Although the indoor restaurant could be approved through the administrative SUP process, staff merged the request in this report with the other uses that require City Council review of an SUP.

City Council Review of Special Use Permits

Section 11-501 of the Zoning Ordinance details the City Council's authority in its review of Special Use Permits: "The city council may approve an application for a special use permit provided for in this ordinance if the proposed location is appropriate for the use and if the proposed use or structure will be designed and operated so as to avoid, minimize or mitigate any potentially adverse effects on the neighborhood as a whole or other properties in the vicinity."

Further, City Council considerations for SUP proposal reviews are found in Section 11-504. Section 11-504(B)(8) states, "Notwithstanding any other provisions of the city code, whether the proposed use will have noise characteristics that exceed the sound levels that are typical of permitted uses in the zone."

Historic District Requirements

Given the location within the Old and Historic District, any permanent exterior changes require BAR approval.

Master Plan Designation

The property at 711 Princess Street is sited within the Braddock Road Metro Station Small Area Plan and the supplemental Braddock Metro Neighborhood Plan, which designate the lot for commercial use.

City Code of Ordinances

The noise ordinance requirements of Section 11-5-5 of the City Code of Ordinances establishes the maximum decibel levels to be measured at the noise source's property lines. The maximum decibel level allowed at the property lines surrounding 711 Princess Street is 60 dB(A).

II. STAFF ANALYSIS

Staff finds the applicant's proposed new uses as a resourceful and creative business response to the impacts associated with COVID-19. The SUP application cites the benefits of outdoor concerts as providing jobs for musicians and offering cultural entertainment for classical music enthusiasts during these inarguably trying times. Although staff acknowledges these economic and cultural benefits, it's evaluation of SUP requests, nonetheless, is limited to the authority granted in the Zoning Ordinance, which directs it to consider "…if the proposed location is appropriate for the use and if the proposed use … will be designed and operated so as to avoid, minimize or mitigate any potentially adverse effects on the neighborhood as a whole or other properties in the vicinity." One evaluation criterion is the effect of excessive sound levels on adjacent properties.

As such, staff recommends partial approval of Classical Movement's SUP requests. Staff supports the restaurant, outdoor dining and indoor live entertainment requests, as reflected in Conditions #1-23. Given the significant likelihood that live outdoor concerts would exceed the noise ordinance of 60 dB(A) at the shared commercial and residential property lines, the location is not considered appropriate for the live outdoor entertainment use, and staff does not recommend approval of this specific SUP request.

Analysis for approval recommendation

Staff believes the indoor live concert entertainment and the restaurant and outdoor dining of up to 50 seats, representing the special events request, could be accommodated on the lot with minimal neighborhood impacts. Indoor live entertainment is not expected to elicit negative impacts as noise would be mitigated due to it taking place inside a building with double-paned windows designed for soundproofing. Nonetheless, the applicant must comply with the noise ordinance and amplified live entertainment may not be heard at the property line after 10 p.m., as stated in Condition #10.

The special events would be offered infrequently and would not include early morning or latenight hours, with limitations for Saturdays and Sundays and hours between 10 a.m. to 10 p.m., as noted in Condition #2. It is reasonable that noise from up to 50 outdoor guests would meet the noise ordinance limitations at the property lines given that 60dB(A) generally equates to the noise level of casual conversation. The outdoor seat limit of 50 is mandated in Condition #4. Although staff does not support outdoor live entertainment as the primary use, it supports outdoor unamplified limited live entertainment, defined as background music, for special events, Condition #9 provides the parameters for limited live entertainment, including a limitation of one musician and the inability to charge admission.

To ensure a suitable number of off-street parking spaces, the applicant is required to maintain parking agreements to provide at least seven off-street spaces within 1,000 feet of the business, as stated in Condition #11. The applicant also volunteered in its application that it would secure additional off-street parking for its larger events and mentioned that opportunities may exist in the Well Fargo bank parking lot across Princess Street.

Analysis for denial recommendation

Given the proximity of the proposed outdoor live entertainment to shared property lines, staff recommends denial for this use. To minimize sound, the applicant proposed two possible stage locations as shown in Figure 5. Although Stage 2 is more removed from the abutting properties than Stage 1, staff found that the distance would not be substantial enough to counter a higher decibel level at the property lines. The distances from the stages to all property lines ranges between 25 and 60 feet.

Should City Council disagree with the denial recommendation for outdoor live entertainment, Conditions #24 and 28 may be adopted to mitigate noise impacts. These are: mandating a maximum of 50 outdoor seats for concerts (#24); limiting days and times (#25); noise ordinance compliance (#26); designation of a community liaison (#27); and event and concert notification to neighbors (#29).

Community Outreach

To ensure the broader neighborhood was aware of the SUP request, the Transportation and Environmental Services' Office of Environmental Quality (OEQ) recommended that the applicant notify residents within a one block radius of the property its application. The applicant diligently complied, delivering 261 letters to surrounding residences, forwarding responses to staff. Several letters of support resulted from the survey and from letters independently sent to the Planning Commission.

CONCLUSION

Staff recommends partial approval for the indoor live entertainment, the restaurant and the outdoor dining and recommends denial for the outdoor live entertainment. Conditions #1-23 apply to the uses recommended for approval. Conditions #24-28 refer to the outdoor live entertainment request if City Council votes to approve the use.

III. RECOMMENDED CONDITIONS

Staff recommends <u>approval for indoor live entertainment</u>, <u>restaurant and outdoor dining</u> subject to compliance with all applicable codes and ordinances and the following conditions:

- 1. The Special Use Permit shall be granted to the applicant only or to any business or entity in which the applicant has a controlling interest. (P&Z)
- Indoor live entertainment, restaurant and outdoor dining are permitted on Saturdays and Sundays, between 10 a.m. and 10 p.m. All patrons must leave the premises at 10 p.m. (P&Z)
- 3. The maximum number of indoor seats for the indoor live entertainment and the restaurant uses shall comply with the state building code. (P&Z)

- 4. The maximum number of outdoor seats for outdoor dining shall be 50. City Council approval is required for an SUP amendment to increase outdoor seating over 50 for outdoor dining. (P&Z)
- 5. The outdoor dining area shall be cleaned and washed at the close of each business day that it is in use. (P&Z)
- 6. The applicant shall conduct employee training sessions on an ongoing basis, including as part of any employee orientation, to discuss all SUP provisions and requirements, and on how to prevent underage sales of alcohol. (P&Z)
- 7. No food, beverages, or other material shall be stored outside, with the exception of materials specified in other conditions. (P&Z)
- 8. On and off premises alcohol sales are permitted in compliance with Virginia ABC requirements. (P&Z)
- 9. Unamplified, outdoor, limited live entertainment, serving only as background music for outdoor dining special events and consisting of one musician, may be offered and must comply with the City's noise ordinance. No admission or cover fee may be charged. All entertainment shall be subordinate to the principal function of the restaurant as an eating establishment. Any advertising of the entertainment shall reflect the subordinate nature of the entertainment by featuring food service as well as the entertainment. (P&Z)
- 10. The indoor live entertainment, restaurant and outdoor dining uses must comply with the city's noise ordinance. No indoor amplified sound shall be audible at the property line after 10:00 PM. (T&ES)
- 11. The applicant shall maintain agreements to meet the minimum seven off-street parking space requirement within 1,000 feet of the business. (P&Z)
- 12. The applicant shall require its employees who drive to use off-street parking. (T&ES)
- 13. The applicant shall encourage its employees to use public transportation to travel to and from work. The business shall contact Go Alex at goalex@alexandriava.gov for information on establishing an employee transportation benefits program. (T&ES)
- 14. The applicant shall provide information about alternative forms of transportation to access the site, including but not limited to printed and electronic business promotional material, posting on the business website, and other similar methods. Contact Go Alex at goalex@alexandriava.gov for more information about available resources. (T&ES)
- 15. The applicant shall encourage patrons to park off-street through the provision of information about nearby garages or lots in the business' advertising and website. (T&ES)

- 16. Exterior power washing of the building shall not be completed using any kind of detergents. (T&ES)
- 17. Chemicals, detergents or cleaners stored outside the building shall be kept in an enclosure with a roof. (T&ES)
- 18. Trash and garbage shall be stored inside or in sealed containers that do not allow odors to escape, invasion by animals, or leaking. No trash or debris shall be allowed to accumulate outside of those containers. Outdoor containers shall be maintained to the satisfaction of the Directors of P&Z and T&ES, including replacing damaged lids and repairing/replacing damaged dumpsters. (P&Z) (T&ES)
- 19. The applicant shall control odors, smoke and any other air pollutants from operations at the site and prevent them from leaving the property or becoming a nuisance to neighboring properties, as determined by the Department of Transportation & Environmental Services. (T&ES)
- 20. All waste products including but not limited to organic compounds (solvents and cleaners) shall be disposed of in accordance with all local, state and federal ordinances or regulations. (T&ES)
- 21. Supply deliveries, loading, and unloading activities shall not occur between the hours of 11:00pm and 7:00am. (T&ES)
- 22. Litter on the site and on public rights-of-way and spaces adjacent to or within 75 feet of the premises shall be picked up at least twice a day and at the close of business, and more often if necessary, to prevent an unsightly or unsanitary accumulation, on each day that the business is open to the public. (T&ES)
- 23. The Director of Planning and Zoning shall review the Special Use Permit one year after it has been operational and shall docket the matter for consideration by the Planning Commission and City Council if (a) there have been documented violations of the permit conditions which were not corrected immediately, constitute repeat violations or which create a direct and immediate adverse zoning impact on the surrounding community; (b) the Director has received a request from any person to docket the permit for review as a result of a complaint that rises to the level of a violation; or (c) the Director has determined that there are problems with the operation of the use and that new or revised conditions are needed. (P&Z)

The following conditions apply, subject to compliance with all applicable codes and ordinances, should City Council choose to <u>approve outdoor live entertainment</u>. If City Council does not approve live entertainment, Conditions 24 through 28 are invalid:

24. The maximum number of outdoor seats for live entertainment shall be 50. City Council Approval is required for an SUP amendment to increase outdoor seating over 50 for live entertainment. (P&Z)

- 25. Outdoor live entertainment is permitted on Saturdays and Sundays between 10 a.m. and 9 p.m. (P&Z)
- 26. The outdoor live entertainment use must comply with the City's noise ordinance. (T&ES)
- 27. The applicant shall designate an employee as a community liaison to respond to property owners' questions and noise concerns. The contact phone number and email for the community liaison shall be provided to these property owners. (P&Z)
- 28. The applicant shall provide at least five-days prior notice to property owners, located one block of the business, of scheduled outdoor concerts and events. (P&Z)

Background

The premier concert tour company for the world's great orchestras and choirs, Blue Heart Travel, Inc. dba Classical Movements typically organizes 60 tours per year, two international choral festivals—Ihlombe! in South Africa and Serenade! in Washington, D.C., Virginia and Maryland, and the Prague Summer Nights: Young Artists Music Festival for Opera. We are extremely proud of our history as a company.

Total Loss of Revenue

However, the past seven months have been perhaps the most difficult in our 28-year history. **Our business has come entirely to a halt.** As we straddle the travel and live music industries, two of the hardest-hit by the COVID shutdown, we are facing a total loss of revenue for the foreseeable future. All of our business (concerts tours and festivals) was cancelled this year and we do not have any contracts for our core business in the future. There will be a longer delay for our business to return to normal because full choirs and orchestras will need to be able to meet for rehearsals and concerts, domestic and international travel restrictions will need to be lifted, and most of them will require a vaccine in order to go on concert tour or attend one of our festivals. Our core business may not come back until late 2021 or, worse and more likely at his point, 2022. Despite all this, we have reinvented ourselves to pull through this crisis and lead the charge for the return of live classical music.

Layoffs and Furloughs

We are committed to remaining open in these difficult times. We laid off 2 employees permanently and we temporarily furloughed 9 employees for one month that are back working full-time right now on reduced salaries. We have been working on other ways to bring in income. We hope to remind our clients that we are still here and operating for their touring needs, ready to get back to work for them as soon as travel commences.

Sources of Temporary Income and Supporting Others

We launched a new virtual education division that includes virtual festivals, individual and group workshops, instrumental master classes, and we are planning more virtual events such as a big sing with guest conductors. Unfortunately, none of these virtual events have brought in much income. **Since our property at 711 Princess Street has been empty since everyone started working remotely, we came up with the idea of having small live concerts, which have been the only source of regular income for us.** Our small live concerts and other ventures act as both a stopgap for our company, but also to play a leading role in reviving the classical music industry. Until touring and travel returns, we are committed to doing the best we can to keep artists and audiences engaged. We are continually developing projects that help out-ofwork musicians. Through this, we also hope to lead the way in helping the performing arts industry to revive and return as soon as possible.

Proposed Use

Page 9 (Q18): Gross building indoor area 5,642 sq. ft. plus gross outdoor area 2,849 sq. ft. = total 8,491 sq. ft. We are requesting to use both indoor and outdoor space on our property so we list the total 8,491 sq. ft. However, we would only use some of the indoor space (most will continue to be office space) and outdoor space (not all of the outdoor space is usable and it includes our private parking area and parts of the outdoor Secret Garden has areas that cannot be used such as the Rose Garden, Other Gardens and Fountain, etc.

Preservation of Historic Property

The Rectory, dating from 1785 formerly served as the rectory of the nearby historic Christ Church, once the church of George Washington. Since then, it has been owned by several distinguished Virginians and has been a commercial office since the 1960's. The 18th century English Secret Garden of the Rectory is a tranquil space complete with its iconic Magnolias. You will be inspired by the garden's peaceful, romantic vintage feel. Located in the heart of beautiful Old Town Alexandria at 711 Princess Street, the Rectory is minutes away from the shops and restaurants of bustling King Street and is easily accessible by bus and metro. Throughout Old Town you'll find the hallmarks of our historic character, from gas lanterns to climbing ivy and wrought-iron gates, not to mention flowers in bloom in the spring. The Rectory has been beautifully preserved and we have invested a lot of time and money maintaining our gorgeous Secret Garden haven rather than develop it like a lot of the other commercial spaces in the city. We would like it to remain one of the celebrated historic properties in Old Town.





Live Entertainment and Restaurant Use in Old Town at Historic City Properties

Many city-owned historic locations in Alexandria have facilities available for rent for a variety of functions, including meetings, seminars, private parties, weddings, and many other special events and they are promoted on the City of Alexandria website. Six Historic Alexandria properties are available for rentals and private events. Our building is as old, if not older than Gatsby's Tavern, which is one of the properties available for rent for a variety of functions. There are also other properties listed such as the Lee-Fendall House Museum & Garden that is a 3 minute walk from our property. They offer indoor and outdoor dining and entertainment in their garden as well.

Outdoor Small Live Concerts

Previous Attempts to Contact the City of Alexandria Zoning Department

In April and May of 2020, we left voice mails and wrote to the City of Alexandria to see what was needed, if anything, to host small live concerts in our outdoor secret garden. We moved forward with our plan to use our outdoor secret garden to host small live concerts when we did not hear back from anyone, thinking there were no issues to do so especially as we are in the CD zone and we are a commercial property.

Giving Hope and Harmony Back to the Community

The concerts are in solidarity with local musicians and our friends in the Alexandria area who are eager to perform live concerts and have had no other opportunities to do so since March. Understanding that music lovers are eager for live performances and that the current situation demands we find new ways to experience live music, Classical Movements has invited musicians from some of our hometown orchestras and other ensembles to join in meaningful and joyous celebrations of the illuminating power of music during this period of so much uncertainty and tension. The concerts give hope and harmony back to the community when we need it most.

First and Only Live Concerts in the US

In June of this year, we started a concert series in our outdoor secret garden, called Sounds of Hope and Harmony, the first and only live classical concert series currently operating in the United States at the time. With strict social distancing guidelines and capacity maximums in place, we launched the series with three short concerts featuring musicians from the National Symphony Orchestra. After a surge of popular demand and positive press, we extended the series into October, with additional concerts of music from traditional classical chamber music, to gospel and spirituals in honor of the March on Washington, to the first live, socially-distanced choral concert in the United States since the beginning of the shutdown.

Partnering with Local Organizations

We have partnered with local organizations like the **Coalition for African Americans in the Performing Arts** and the **Alexandria Symphony Orchestra** to present concerts with meaningful programming.



Showcasing Black Musicians and Composers and Women Composers

We are making a deliberate effort to showcase Black musicians and composers, as well as women composers across our season – which has always been an essential part of our artistic mission. Before the delays and cancellations necessitated by Covid-19, we had planned an ambitious series of new music commissions, including 5 in honor of the centennial of women winning the vote in America.

Supporting Out-of-Work Musicians and Conductors

Ticket sales are used to pay the musicians and conductors. Classical Movements has supported 74 out-of-work musicians, of which 31 were women and 21 performers of color, and programmed 94 different works by 88 composers including 33 living composers. The performers have been out of work musicians from the National Symphony Orchestra, Alexandria Symphony Orchestra, Annapolis Symphony Orchestra and other local organizations.



Cancelled Events

After increased popular demand, we extended the series into the holidays with our Sounds of Joy and Light series, with concerts for Halloween, Thanksgiving, Christmas, Hanukkah, and Kwanzaa. We have since cancelled events as we apply for this permit. Looking ahead, we are hoping to get this permit so that we can extend the series and have more concerts.

Supporting Local Music Organizations

We have also rented our outdoor Secret Garden to local orchestras such as the **Alexandria Symphony Orchestra** and the **Eclipse Chamber Orchestra**, who hosted their own small live concerts. We hope to offer our outdoor Secret Garden to other local music organizations to have concerts outdoors. As you know, they are also without any income during COVID-19.



No Cases of COVID-19 Reported

Concerts take place in the beautiful Secret Garden at the Rectory on Princess Street, Classical Movements' home in Old Town Alexandria. No cases of COVID-19 have been reported as a result of our concerts since their start in June. Concerts are carefully designed to accommodate safe social distancing for performers, audience and staff. We operate at a very limited capacity and distribute programs and tickets by email only. Musicians are assigned specific spaces backstage and we maintained a strict regimen of cleaning between performances.

Benefits to Other Local Businesses

The small live concerts have also benefited other local businesses. We have used Best Impressions to print signs and flyers. We have used Door to Door Distributors to distribute postcards advertising the concerts. Other local business such as Fitness Together and Ideatech Associates have sponsored events and gained more customers and business from the concerts. We feed the musicians and staff using local Alexandria restaurants to support them. We have also reached out to local individuals, banks and corporations who are also interested in supporting the concerts and in turn, the local music organizations, musicians and conductors, etc.

One Hour Concerts

The small live concerts are for one-hour each maximum. We typically arrange two concerts on one day using the same program and musicians, with a 30 minute break to clean in between concerts.

Precautions

Classical Movements continues to take precautions to limit the risk as much as within our power and requests the cooperation of the audience in these preventative measures so that we can continue to enjoy live music and support musicians in our community. The measures include, but are not be limited to the following: There are temperature checks for all who attend. Audience members are required to bring and wear face coverings. Classical Movements staff wear face coverings. Musicians wear face coverings when not performing. Seating is provided for concerts, with chairs wiped down and disinfected between performances. Chairs have at least six feet between individual or family groups (after the chairs are removed, we use markers to measure distances). The indoor and outdoor space is wheelchair accessible. To maximize social distancing, seating is assigned by us. Tickets and programs are distributed digitally to minimize the need for physical proximity (this also reduces the trash you ask about in the application). The stage and musicians are at least 10 feet from the front row. Hand-sanitization stations are available for audiences as they arrive and exit. There are capacity maximums following state and local guidelines. Additional measures and instructions are provided to audience members the week of the concert by email and text.

Proposed Days and Hours of Operation for Concerts

Concerts would take place occasionally and not daily. Concerts presented on any day of the week would be scheduled in advance. For example, we would arrange them on a Saturday but in case of severe weather, the rain date would be the following Sunday. They will all be one-hour concerts. Some dates will have one concert, most will have two concerts, and on special occasions we may have two concerts during the day and two concerts in the evening. During the day, we would schedule two concerts at 1:00 PM and 2:30 PM or 2:00 PM and 3:30 PM for example. During the evening, we would schedule two concerts at 5:00 PM and 6:30 PM (winter) or 6:00 PM and 7:30



PM (summer) for example. We expect to have concerts 4 days/month and 6 months/year.

COVID-19 State Guidelines

Classical Movements will follow the laws of the Commonwealth of Virginia. This includes the Governor's executive actions in regards to temporary restrictions due to COVID-19 limiting public and private in-person gatherings indoors and outdoors for entertainment and amusement businesses and performing arts venues, concert venues. During COVID-19, we have only wanted to use the outdoor Secret Garden, regardless of the temperature or weather, where there is ample space and fresh air. During COVID-19, we are having outdoor concerts, and avoiding indoors at this time per the recommendations of the CDC.

Concert Program Examples

Examples of Concerts:

Example 1: "The Four B's: Barrière, Bologne, Bartok and Beethoven" for Chamber Music. Members of the National Symphony Orchestra: Eugena Chang, Cello, Britton Riley, Cello, Alexandra Osborne, Violin, Angelia Cho, Violin, Mahoko Eguchi, Viola, Rachel Young, Cello. Vibrant, daring and ravishing music by Beethoven, Bartok, Bologne, Chevalier de Saint-Georges, Barrière, Joplin and others.

Example 2: "Prague Comes to Washington" – An Evening of Art Song and Opera. Javier Arrey, baritone, Kaylee Norris, soprano, and Taylor Hutchinson, piano. Featuring Metropolitan Opera star and Chilean baritone, Javier Arrey and Kaylee Norris, winner of the Prague Summer Nights Young Artists Music Festival voice competition. The program includes Beethoven's superlative song cycle "An die ferne Geliebte" in celebration of the 250th anniversary of his birth, Dvorak's beautiful "Biblical Songs", as well as charming arias and art songs by Mozart, Stravinsky, Brahms, Liszt, and others.

Example 3: "Sweet Songs of Sorrow and Joy" * – An Evening of Music Celebrating Civil Rights on the Anniversary of the March on Washington. Alexandria Crichlow, soprano, V. Savoy McIlwain, baritone, Lester Green, piano, Pamela Simonson, the narrator. In collaboration with CAAPA (Coalition for African Americans in the Performing Arts). Program with Spirituals, Freedom Songs, Gospel, and Civil Rights Anthems. *"God has wrought many things out of oppression. He has endowed his creatures with the capacity to create—and from this capacity has flowed the sweet songs of sorrow and joy that have allowed man to cope with his environment and many different situations... This is triumphant music." – Dr. Martin Luther King, Jr.

Example 4: "A Brand New Day:" Choral Music Returns! The Choir of Hope & Harmony with Anthony Blake Clark, conductor. 12 professional singers perform 400 years of compelling choral music by Byrd, Britten, Panufnik, Coleridge-Taylor, Barnett and more on themes of hope in times of uncertainty.

Example 5: 7 Musicians from the Alexandria Symphony Orchestra. Beethoven's uplifting Septet for winds and strings and Piazzolla's iconic tango "Oblivion" will mingle in the fresh outdoor air of the "Secret Garden" in the heart of Alexandria's Old Town. Featured bandoneonist Emmanuel Trifilio will transport us to a night club in Buenos Aires, even as Beethoven's melodies linger in the garden atmosphere. ASO Music Director Jim Ross steps to the podium for the first time since February to conduct musicians of the ASO in this remarkably creative program.

Example 6: Drew Owen, magician and cellist with Elizabeth Pulju-Owen, violinist. Fun for the whole family when musical wizard Musico the Magnificent and special guest astonish and amuse



with stunning feats of magic and phenomenal music for cello; also featuring costume prizes, socially distanced photo station, and sanitized, no-contact treats.

Example 7: Members of the National Symphony Orchestra. Marissa Regni, violin, Peiming Lin, violin, Derek Powell, violin, Allyson Goodman, guest viola, and Loewi Lin, cello. The Secret Garden travels to Venice for a spellbinding program by string players from the National Symphony Orchestra; add a Carnival masque to your face covering for an elegant Halloween with gorgeous music, including the "Autumn" Concerto from Vivaldi's Four Seasons, Puccini's "Crisantemi" and other Italian composers.

Example 8: Members of the Eclipse Chamber Orchestra. Eclipse Chamber Orchestra is comprised of the Washington DC area's finest musicians, many of whom are members of the National Symphony Orchestra. Known as "An Orchestra of Soloists", Eclipse presents world-class performances in concert venues, schools, and community centers to make classical music more accessible to all. The Beau Soir Ensemble is a flute, viola, and harp trio dedicated to the performance of standard and contemporary repertoire spanning a variety of musical genres.

Indoor Small Live Concerts

In addition to the outdoor Secret Garden, in the future, we will use our indoor space to host small live concerts. We have an atrium space that can accommodate a smaller, more intimate live concert. We also have a large room that we call the ballroom.

Double Paned and Sound Proofed Windows

Because of the construction noise from Sunrise Senior Living and additional traffic on our street from them and the FedEx/UPS drop off as well as other commercial businesses on our street, we invested \$35,000 to have all of our windows double paned and sound proofed.

Music Masterclasses and Workshops

We are allowed to have a school as permitted in zone CD. We will hire professional musicians to give one-on-one and small-group private instruction, masterclasses and workshops in our building. As mentioned above, we invested \$35,000 to have all of our windows double paned and sound proofed. This would take place inside the building. Related to this, we would have the students perform summer recitals as part of the outdoor small live concerts. This would give private students a special opportunity to work with and perform with professional musicians.

Live Music with Catered Meal

After the success of our small live concerts, we wanted to support our neighbor who has also lost a significant amount of income. We hosted one small live music concert in collaboration with Seasons Culinary Services with an exquisite socially-distanced dining experience. The food was prepared off property at another location they have outside of the City of Alexandria and brought on site. The tables were socially distanced and measured 6 feet apart. Surfaces were disinfected between seatings. There were no menus as the meal was set courses. The servers always wore a mask and gloves to handle and serve food. The attendees also always wore a mask except for when at their table eating. The caterer handled the clean up and removed everything back off site. Our property aligns with their property through our co-joined driveways, so there was no disruption on the street.



Proposed Days and Hours of Operation for Concerts

If permitted to continue small live music concerts with dining using a caterer, we were considering some of the following options. These events would be special occasions and not frequent. They would most likely take place on the weekend, such as a Saturday during the day, afternoon or evening. They may take place on a federal holiday. We do not envision having these events during the work week.

Example 1 at 5:00 PM and 8:00 PM: Savory Soiree – An Elegant 4-Course Musical Dining Experience with Marianna Prjevalskaya, piano. In collaboration with Seasons Culinary Services and featuring a stunning performance by internationally acclaimed pianist Marianna Prjevalskaya, join us for a "Savory Soiree" in the Secret Garden for an elegant evening of gourmet food paired with wine and live music by composers sharing a birthday on November 14th: Johann Nepomuk Hummel, Fanny Mendelssohn, Aaron Copland and Buckwheat Zydeco. "Music and food are two of the greatest forces of unity. In that spirit, we look forward to creating a meal to remember!" Guests will enjoy four delectable courses, each paired with select wines and a wide-ranging repertoire of music by four composers who celebrate their birthday on November 14.

Example 2: Mother's Day Afternoon Tea with Live Music.

Weddings

We would like to rent the property to be used for occasional 2-, 3-, 5- and 8-hour weddings and other events. During COVID-19, many have had to cancel their weddings and downsize. We wanted to offer our beautiful Secret Garden to be used. Examples would be, an intimate Secret Garden elopement for 2 hours and 10 guests, Secret Garden wedding ceremony for 3 hours with seating for 50, atrium wedding ceremony for 3 hours and seating for 24, Secret Garden wedding reception with catering for 5 hours and seating for 50, atrium wedding reception for 5 hours with catering and seating for 24, Secret Garden wedding ceremony and reception for 8 hours with catering and seating for 50, atrium wedding ceremony and reception for 8 hours with catering and seating for 24. All events must end by 10 PM, including clean up. The number of guests would follow the Governor's executive actions as required by law.

Proposed Days and Hours of Operation for Weddings

Weddings would take place occasionally and not daily. Weddings would often be on a Saturday or Sunday. Weddings would take place 10-12 PM, 12-2 PM, 2-4 PM, 10-4 PM or 5-10 PM for example. **We expect to have weddings 4 days/month and 6 months/year.**

Other Events

Events may be bridal showers, baby showers, engagement and other intimate events, corporate meetings, seminars, and other private events (for others who want a change of scenery, as our business is already used for this purpose as a JR Office Building), photography and video sessions. We have supported local wedding planners, caterers, bakers, florists, fashion designers, wedding shops, models, etc. who have used our property to take styling shoots in order to promote their services.

Proposed Days and Hours of Operation for Other Events

Other events would take place occasionally and not daily. Other events would be indoors or outdoors, and could be during the weekday. They would take place 10-12 PM, 12-2 PM, 2-4 PM, 10-4 PM or 5-10 PM for example. We expect to have other events 1 day/month and 6 months/year.

Additional Property Policies

Those that rent the property for weddings and other events will need to follow these guidelines and more:

- All indoor and outdoor activity (including cleaning and packing up by subcontractors like caterers) must be completely finished no later than 10:00 PM.

- Outdoor music must be no louder than sixty (60) decibels. Absolutely no amplified music or microphone announcements are allowed in the building or garden. No DJ's or singers with microphones are allowed. This includes stereos, or any other instruments or equipment which requires a microphone, speaker, batteries, or are plugged into an electrical source without special permission. Please submit your music program for review and approval prior to the event. The Venue reserves the right to deny music requests that are not appropriate for the area. The Venue reserves the right to intervene during an event on behalf of neighboring properties or upon external complaint to reduce the level of noise. The Renter will be subject to any and all fees by the City of Alexandria in violation of the noise code.

- Smoking (including cigars, chewing and pipe tobacco, vaporizers, and e-cigarettes) is prohibited in any space, indoor or outdoor, within property lines of the Venue.

- No illegal drugs or illicit substances are allowed on the property. Nudity is not permitted.

- All decorations and signage must be approved in advance by the Venue or the Venue's designated representative. Decorations and signage is not allowed on the painted walls, windows, floors, ceilings, wood bannisters, or furniture. Nothing is to be hung from the ceilings or lights. The use of tape, duct tape, tacks, glue, hooks, nails or other wall-inserted devices to attach decorations is prohibited. If any of these items are used your security deposit could be forfeited. The use of clear tape may be used on the outside external walls of the building (not on the painted walls or windows) to post signs. All decorations must be removed and the property surrendered in the same order and condition as it was received. The Renter is responsible for any damage which may be more than your security deposit.

- All trash and other materials must be removed and the property surrendered in the same order and condition as it was received. The Venue has designated trash cans that can be used to store trash but the Renter must provide their own trash bags and then it must be removed from the property after the event. The Renter is responsible for any trash and other materials left on the property and your security deposit could be forfeited.

- All food must be prepared off site except for beverages, but food can be warmed on site with prior Venue approval. No cooking over a gas flame or with hot oil is permitted. Renters who plan to serve alcoholic beverages must use a licensed and insured caterer or bartender to provide and serve all alcoholic beverages. Renters who plan to have a cash bar or to charge admission are responsible for obtaining any necessary permits and licenses. All ABC regulations must be complied with (caterer or bartender license or temporary alcohol license). A copy of your final catering and/or bartender contracts may be requested by Venue to have on file.

- The use of hay, straw, cornstalks, dry tinder, or any highly flammable material is not permitted. Glitter, rice, bird seed, real flower petals, silk flower petals, and confetti are prohibited. Messy activities (such as pumpkin carving, painting, etc.) are only permitted proper floor covering with pre-approved by the Venue or the Venue's Representative. Only natural bubbles and sugar confetti (dissolvable) may be used outside. The release of balloons is prohibited.



- Hoverboards, bicycles, skateboards, scooters, roller skates, and other self-propelled vehicles (other than devices required for medical use such as motorized wheelchairs) are not to be used on the property of the Venue.

- No animals (other than service animals) are allowed on the property.

- Firearms and fireworks of any kind are prohibited. Open flames (including candles and incense) are prohibited without the express prior written consent of the Venue or the Venue's Representative. Electronic devices (such as electric candles) may be used to mimic the appearance of candles. Cost for damage due to candle use will be assessed to the Renter.

- Indoor hallways are to be kept clear and unobstructed to allow for free and flowing access.

- Additional lighting (including electric string lights) are not to be used without prior written consent of the Venue or the Venue's Representative.

- During regular weekday business hours, the Renter must be mindful of several adjacent offices when planning activities in surrounding common spaces.

<u>Retail Note</u>

As allowed by zoning, we explored the option of retail on the property, such as a music store or indoor/outdoor garden center, but with most of King Street empty, retail shops going out of business, and COVID-19 restrictions, we did not explore further, even if it is an option for our property. It may be an option we explore again in the future if we are unable to have Live Entertainment and Events at our property.

Neighbors

Sunrise of Alexandria Propco LLC, 400 N Washington St

We have a close relationship with the Senior Living Community. We started discussions with them about a possible partnership for a concert series. They mentioned that they received special requests for units facing our Secret Garden and that it enhances their property. It was mentioned in passing, that some units sold as well, knowing that there are outdoor concerts in our Secret Garden. It should be noted that their loading and unloading entrance/exit is immediately to the right of our property on Princess Street. There will be daily traffic for ongoing construction, garbage/refuse, laundry, food services for their restaurant, mail delivery, express delivery, courier and shipping services, ambulances, visitors and others. There are trees and bushes that surround the garden along with 6 and 8 foot fencing.

Williams Whittle, 711 Princess St, 2nd Floor

The tenant on the second floor, which is an advertising agency, and previous owners of the property, support and attend the concerts.

Staff Restaurants LLC, 715 Princess St

On the left, our private driveway is connected to another private driveway and the Seasons Culinary Services business. That property and the one adjacent on the corner are both zoned as Jr Office Buildings. As mentioned above, we hope to continue to support them with future catered events. **They have also given us permission to use their 4 private parking spots.**



409 and 411 N Columbus St

Behind us and next to all of the commercial properties surrounding us, there are two private row homes. One on the back left of our driveway and the other at the end of our driveway. Across from them on N. Columbus Street is the Democracy Federal Credit Union and parking lot with traffic. Commercial properties surround them on all sides.

Wells Fargo, 330 N Washington St

Wells Fargo has a parking lot and drive thru across the street from our property on Princess St. There is also more parking across the street for townhomes and other businesses.

Fitness Together, 300 N Washington St Ste 106 (Across Street through Parking Lot)

Fitness Together, at the end of the parking lot across the street, also support and attend our concerts. They also were a sponsor of our concert series, along with other businesses, and gained new business. **They have also given us permission to use their 4 private parking spots**. The parking has entrances on Princess St, N Columbus St, N Washington St and Queen St.

Environment

The airplanes that fly over the property and the birds chirping in the trees have been louder than the music playing. Our property is about 170 feet from N. Washington Street. The traffic from this street along with the traffic on Princess Street is more disruptive as well, but we have learned to make the best of the situation.

Other Alexandria Attendees and Neighbors

We include what attendees, neighbors and others have said about our space and concerts later in this document. We will be supplementing this application with individual letters of support. Some will also attend the hearings.

Parking

Most of our guests are local or use the metro and then walk to the property. For any that drive, we use our private parking on the property. We have 6 parking spots on our property including a handicapped accessible spot. We have permission to use 4 private parking spots from Seasons Culinary (Staff Restaurants LLC) which is at 715 Princess St next door. Our private driveways are attached. Additionally we also have permission to use 4 private parking spots at Fitness Together which has an entrance across the street from our property on Princess St as well as on Queen, N Columbus and N Washington. If we had an event that required more spots, we would secure them at one of the private parking garages within walking distance to our building.

Zone and Permitted Use Options

The CD zone is intended to provide for an urban mix of retail, office, service, hotel, residential and civic functions for the city's downtown business core.

The CD zone permits use for animal care facilities, day care centers, private schools, public schools, retail shopping, farmers' markets, health and athletic clubs, restaurants, outdoor dining, amusement enterprises, apartment hotel, food and beverage production, bed and breakfast accommodations, catering operations, banks, savings and loan institutions and credit unions with drive through facilities, fraternal and private clubs, funerals homes, cemeteries, churches, continuum of care facilities, homeless shelters, hospitals, hotels, medical care facilities, parking or storage, outdoor garden centers, rooming houses, etc. Some do not require a SUP application.

Last Resort

Without any source of income, we would need to use the property in another manner that would allow us to stay in business, if this application is not approved. We would have to keep exploring options for the property before we went out of business. Since the owner of Classical Movements is



also the owner of the property, we could look at renting to someone else to use the property as allowed by zoning or with SUP application approval or we would need to sell the property.

We are trying to do the best we can for our employees, local music organizations and musicians, and other local businesses out of work or with reduced income, and the community. It's coming up on four months since the <u>coronavirus</u> scattered every cluster of the classical music community back to their respective abodes, and over the course of this eerie interim, it's as though a whole new set of instincts has set in to replace the old ones. In the past, my preparations for a concert involved listening to the work a few times, finding a trustworthy pen and eating a big enough lunch to keep my stomach from joining in with the orchestra.

Saturday afternoon's checklist was a bit more thorough.

I was preparing to head to Old Town Alexandria, where the local orchestral and choral touring company Classical Movements was hosting "Sounds of Hope & Harmony," an outdoor trio of hour-long chamber concerts in the "Secret Garden" tucked behind its former-rectory headquarters on Princess Street. But it felt like I was preparing for battle.

I had my mask — two of them, actually — a blue plaid number that seemed formal enough to block pathogens at a garden party. I had a small bottle of Purell. A big bottle of water. A hankie for lens fog. An umbrella and a raincoat for the looming thunderheads. A printout of my assigned location in the garden (No. 11 of 35 or so reserved spots). And my usual kit of reporter stuff — phone, pad, pen. I also had a serious case of nerves.



Riding to the rectory in the back of a Lyft, I took shallow breaths (which I'm sure is effective) and hung my head halfway out the open window with all the enthusiasm of a golden retriever en route to the vet. It was raining, and the ominous droplets pelting my forehead felt like tiny omens that I should turn around and go back to the apartment, that this was all too soon, that it was actually crazy. My phone said crowds were starting to form at President Trump's campaign rally in Tulsa, and I felt around my tote bag to make sure I had my inhaler.

But upon reaching the garden, the rain stalled, the clouds parted, the sun glimmered through the trees, and the sounds of nearly two dozen musicians tuning in the various rooms of the 235-year-old rectory filtered into the courtyard. It was the sound of music preparing to return; and just like that, my jitters subsided.

This time out, hand-sanitizing stations stood at the ready and little flags staked out each listener's spot for standing, six feet apart (though couples could cluster). It felt odd at first, but also oddly luxurious if you've ever been vexed by the personal space afforded by seats in a concert hall. Attendees improvised their hey-I-know-you reunions in the rows through a mix of elbow bumps and weird waves and salutes.

The musicians, too, had some improvising to do. Ensembles representing the Alexandria Symphony Orchestra, the National Symphony Orchestra, the New Orchestra of Washington, as well as the Barclay Brass ensemble (which includes members of the Maryland, Annapolis and Fairfax symphony orchestras) were staggered across the three programs and spread around the stage — the unfamiliar acoustics of socially distant performance requiring more reliance on visual cues between the players.

A quintet of horn players from the Alexandria Symphony Orchestra opened the evening easing into selections from Giles Farnaby's "Fancies, Toyes, and Dreams" before seguing into "That's a Plenty," a 1914 rag-turned-jazz-standard by Lew Pollack, and one of a few detours into ragtime that lent the program a disarming lightness. Members of the NSO later took on Scott Joplin's "Maple Leaf Rag" and Earclay Brass chased the second suite from Handel's "Water Music" with Allen Toussaint's "Java." (And in all cases, even when a rag sounds a little rusty, it feels right.)

The wind quintet of National Symphony Orchestra players also gave a brilliant account of Valerie Coleman's "Umoja" (written for Imani Winds) that held court against the noisy birds in the tulip magnolia above us. And a quintet of string players from the Alexandria Symphony Orchestra showcased the skilled interplay of concertmaster Claudia Chudacoff and violinist Peter Haase, delivering a stirringly beautiful selection from Mozart's Divertimento No. 4 in D.

Their take on Shostakovich's lovably stumbling polka from "The Golden Age" — and its grasping toward a familiar form — felt freshly relatable; and likewise, their closing selection of "Toreador Song" from "Carmen" felt appropriately victorious for the occasion. After all, we'd made it!

Much like those nervously gathered to listen, the program was a little all over the place; but the intimacy of the experience — and our collective hunger to hear just about anything — gave the feeling that audience and performers were conducting the same experiment: just being there. Even before the first notes were played, I found myself getting lost in the music of chitchat and laughter — our own birdsong.

And while there were little reminders of the virus — the wiping down of musicians' seats between sets, the concerted effort to avoid touching the microphone, somewhat-matchy masks — it never overshadowed the evening. (The sun sails hung overhead did that, while helping keep the music contained from the roar of landing planes.)

For audience and musicians alike — and especially for Helms and her team, who found themselves immediately fielding questions about when the next concert will be (they're figuring it out) — the various tweaks, compromises and precautions required to realize something as simple as a night of music felt like a major achievement. I was tempted to high-five my neighbors in audience but, well, you know.

As the cancellations mount up for performing arts organizations, most are continuing their valiant efforts to stay in the public eye online.

Stay in the purce events. A few brave souls are complementing that with small outdoor events, using safety protocols that are perhaps awkward and labor-intensive to execute, but nonetheless worth it, both for the players and the listeners. Among the first to go the al fresco route was the Minnesota Orchestra, earlier this month announcing a series of <u>24 chamber concerts on the adjacent Peavy Plaza</u> in August, each lasting no more than 20 minutes (no intermission), requiring advance reservations, face masks, temperature screenings, and keeping to a total capacity--including staff--of 250. Ensemble size is up to eight.

The Detroit Symphony has since followed a <u>similar path</u> – small ensembles of DSO musicians performing six concerts out of doors in varying locales, some of which require reservations; all events are free with strict protocols in place for social distancing (those who don't follow the rules will be asked to leave); no seating provided—BYOBlanket.

The San Francisco Symphony, which has a new online series titled Currents, also has joined the al fresco crowd with its <u>1:1 Concerts</u>, bringing a new level to intimacy—literally one orchestra member performing for one listener at a time, using the Davies Hail outdoor terraces. First priority goes to donors, volunteers, etc., but it appears they may be available to the general public as well.

Classical Movements just launched the first of an ongoing outdoor series in Alexandria, VA, titled <u>Sounds of Hope and Harmony</u>. National Symphony Orchestra musicians are among the performers and tickets can be purchased through CM's website. Planned to continue through October 4 on Saturday evenings, the 18 concerts take place in a church garden in Old Town, Alexandria, and feature a range of repertoire. Kudos to all for fighting the uphill battle of the pandemic.

Live soft classical music with no amplification and socially distanced attendees and staff are limited in size. With the way the property is set up, less than 60 decibels at the property lines.

B. How will the noise be controlled?

The outdoor garden is surrounded on all sides by our three story office building, tall 6 and 8 ft. fencing, 10-30 ft trees around property, and the Sunrise Senior Living property so the noise is contained. The windows of the office building were recently double paned to reduce noise due to the ongoing construction and traffic at the Sunrise Living Community, parking lot across the street, and bank with drive thru. The people that that attend events are limited, and set apart to ensure safe social-distancing for everyone, and they wear face coverings. Therefore they do not linger and/or socialize before, during or after the events. For other events, we have strict guidelines about what is allowed. See narration. **8.** Describe any potential odors emanating from the proposed use and plans to control them:

On limited occasions, if we have a catered event with food, the food preparation will take place off site. There is a small kitchenette in the building to stage the food for service. No cooking will take place on the property. Then the refuse, food and service equipment is taken off site immediately after the event.

- **9.** Please provide information regarding trash and litter generated by the use.
 - A. What type of trash and garbage will be generated by the use? (i.e. office paper, food wrappers) For a normal live performance event, there is no trash or garbage generated. If a warm beverage is included the cups are given after the event and attendees take them with them or a trash receptacle is provided and taken away by waste management. We use Waste Management Trash and Recycling for weekly pick up and Thompson Hauling & Recycling and Shred-It for special pick ups as needed if above the regular amount of trash and garbage generated as an established commercial building.
 - B. How much trash and garbage will be generated by the use? (i.e. # of bags or pounds per day or per week)

We estimate to have 1 bag or less of trash generated per week. For special events, our policy is that the renter or contracted caterer would need to take the trash away immediately after the event to dispose of it properly and not left on our property.

C. How often will trash be collected?

We have weekly service with Waste Management Trash and Recycling. We use Thompson Hauling & Recycling and Shred-It for other trash collection needs. Trash will be collected weekly or if needed as an exception we would schedule a special pick up. Covanta Alexandria Waste Management facility on Eisenhower or the Recycling Drop Off Center in Alexandria on Eisenhower.

- D. How will you prevent littering on the property, streets and nearby properties? We have a trash receptacle at the entrances/exits of the garden and building. Our events do not have any printed materials as due to COVID-19 everything is provided electronically. For other events, the renters are contracted to remove all trash from the property on their own or through their contracted caterer or they are in breach and lose their security deposit. If there is ever a situation of trash, we will schedule a special pick up as needed by Thompson Hauling & Recycling who we have worked with 18 years. Or drive to the Covanta Alexandria waste Management tacility on the Recycling Drop UT Center in Alexandria on Eisenhower or.

The property owners and Classical Movements are insured with general liability, property, worker's comp, errors and ommissions, professional liability and other insurance. All vendors are required to also provide proof of insurance. People that rent are required to have event insurance.

Dear Ann,

Please see further clarification as requested in blue.

1. You mention that concerts, weddings and rentals will occur six months out of the year. Please identify these months.

Most concerts and concert related rentals will take place in March, April, May, June, July and August with possible very limited special events around holidays outside of those months. The goal of the concerts would be to arrange them until the end of August because we are hopeful that our concert touring business will restart in September. This is new to us so we are doing our best to predict. We also have not made concrete plans yet. We are doing this because we have no income from our regular touring business until 2022. Of course we would like to take any business we can because we have to get any income we can to keep our company going and pay our staff. In regards to weddings and other rentals, most will take place in May, June, July, August, September and October. There may be limited events outside of those months. We are finding that during the pandemic there is a need for short term planned micro weddings. It is important for everyone to note that we have small indoor spaces that would normally be used. It is only during COVID that we are focused on outdoor events for the safety of the public.

2. A range of hours through the day are marked as the times you would hold concerts and events. For example, you state that concerts will take place 1-2, 2:30-3:30, 5-6, 6:30-7:30, 7:30-8:30. By listing all these dates do you mean that you would hold five concerts a day?

The times listed were only to give you an idea of possibilities. During the day, we would schedule two concerts at 11:00 am and 12:30 PM OR 1:00 PM and 2:30 PM OR 2:00 PM and 3:30 PM for example. During the evening, we would schedule two concerts at 5:00 PM and 6:30 PM (winter) OR 6:00 PM and 7:30 PM (summer) for example.

a. If not, how many concerts would you hold a day? We will typically arrange one concert program which is two one-hour concerts on one day using the same program and musicians with a 30 minute break to clean in between concerts. The small live concerts are for one-hour each. Concerts would take place occasionally. Concerts presented on any day of the

week would be scheduled in advance. For example, we would arrange them on a Saturday but in case of severe weather, the rain date would be the following Sunday. They will all be one-hour concerts. Some dates will have one concert, most will have two concerts, and on rare occasions we may have two concerts during the day and two concerts in the evening. In the summer, we would have them in the morning or in the evening. In the spring, we would have them in the afternoon or in the evening. The times listed were only to give you an idea.

- b. How many weddings would you hold a day? In most cases there would be one wedding per day and per week on a Saturday or Sunday. Weddings would take place occasionally and not daily. Weddings would take place 10-12 PM, 12-2 PM, 2-4 PM, 10-4 PM OR 5-10 PM for example. We expect to have weddings 4 days/month and 6 months/year.
- c. How many rentals would you schedule a day? We can probably only hope for one concert program and one rental (wedding or other event) per week at most and highly unlikely they would be on the same day.
- d. Would any of these events take place simultaneously? We think it is highly unlikely that we would have more than one event at a time.

How many parking spaces are you able to use at the neighboring property and could that property owner email me with an acknowledgement that they permit you to use the spaces?

Most of our guests are local or use the metro and then walk to the property. For any that drive, we use our private parking on the property. We have 6 parking spots on our property including a handicapped accessible spot. We have permission to use 4 private parking spots from Seasons Culinary (Staff Restaurants LLC) which is at 715 Princess St next door. Our private driveways are attached. Additionally we also have permission to use 4 private parking spots at Fitness Together which has an entrance across the street from our property on Princess St as well as on Queen, N Columbus and N Washington. If we had an event that required more spots, we would secure them at one of the private parking garages within walking distance to our building.

Staff Restaurants LLC, 715 Princess St: On the left, our private driveway is connected to another private driveway and the Seasons Culinary Services business. That property and the one adjacent on the corner are both zoned as Jr Office Buildings. As mentioned above, we hope to continue to support them with future catered events. They have given us permission to use their 4 private parking spots. I have attached their email to this one.

Fitness Together, 300 N Washington St Ste 106 (Across Street through Parking Lot): Fitness Together, at the end of the parking lot across the street, also support and attend our concerts. They also were a sponsor of our concert series, along with other businesses, and gained new business. They have given us permission to use their 4 private parking spots. The parking has entrances on Princess St, N Columbus St, N Washington St and Queen St. I will forward you their email shortly.

It's coming up on four months since the <u>coronavirus</u> scattered every cluster of the classical music community back to their respective abodes, and over the course of this eerie interim, it's as though a whole new set of instincts has set in to replace the old ones. In the past, my preparations for a concert involved listening to the work a few times, finding a trustworthy pen and eating a big enough lunch to keep my stomach from joining in with the orchestra.

Saturday afternoon's checklist was a bit more thorough.

I was preparing to head to Old Town Alexandria, where the local orchestral and choral touring company Classical Movements was hosting "Sounds of Hope & Harmony," an outdoor trio of hour-long chamber concerts in the "Secret Garden" tucked behind its former-rectory headquarters on Princess Street. But it felt like I was preparing for battle.

I had my mask — two of them, actually — a blue plaid number that seemed formal enough to block pathogens at a garden party. I had a small bottle of Purell. A big bottle of water. A hankie for lens fog. An umbrella and a raincoat for the looming thunderheads. A printout of my assigned location in the garden (No. 11 of 35 or so reserved spots). And my usual kit of reporter stuff — phone, pad, pen. I also had a serious case of nerves.


Riding to the rectory in the back of a Lyft, I took shallow breaths (which I'm sure is effective) and hung my head halfway out the open window with all the enthusiasm of a golden retriever en route to the vet. It was raining, and the ominous droplets pelting my forehead felt like tiny omens that I should turn around and go back to the apartment, that this was all too soon, that it was actually crazy. My phone said crowds were starting to form at President Trump's campaign rally in Tulsa, and I felt around my tote bag to make sure I had my inhaler.

But upon reaching the garden, the rain stalled, the clouds parted, the sun glimmered through the trees, and the sounds of nearly two dozen musicians tuning in the various rooms of the 235-year-old rectory filtered into the courtyard. It was the sound of music preparing to return; and just like that, my jitters subsided.

This time out, hand-sanitizing stations stood at the ready and little flags staked out each listener's spot for standing, six feet apart (though couples could cluster). It felt odd at first, but also oddly luxurious if you've ever been vexed by the personal space afforded by seats in a concert hall. Attendees improvised their hey-I-know-you reunions in the rows through a mix of elbow bumps and weird waves and salutes.

The musicians, too, had some improvising to do. Ensembles representing the Alexandria Symphony Orchestra, the National Symphony Orchestra, the New Orchestra of Washington, as well as the Barclay Brass ensemble (which includes members of the Maryland, Annapolis and Fairfax symphony orchestras) were staggered across the three programs and spread around the stage — the unfamiliar acoustics of socially distant performance requiring more reliance on visual cues between the players.

A quintet of horn players from the Alexandria Symphony Orchestra opened the evening easing into selections from Giles Farnaby's "Fancies, Toyes, and Dreams" before seguing into "That's a Plenty;" a 1914 rag-turned-jazz-standard by Lew Pollack, and one of a few detours into ragtime that lent the program a disarming lightness. Members of the NSO later took on Scott Joplin's "Maple Leaf Rag" and Barclay Brass chased the second suite from Handel's "Water Music" with Allen Toussaint's "Java." (And in all cases, even when a rag sounds a little rusty, it feels right.)

The wind quintet of National Symphony Orchestra players also gave a brilliant account of Valerie Coleman's "Umoja" (written for Imani Winds) that held court against the noisy birds in the tulip magnolia above us. And a quintet of string players from the Alexandria Symphony Orchestra showcased the skilled interplay of concertmaster Claudia Chudacoff and violinist Peter Haase, delivering a stirringly beautiful selection from Mozart's Divertimento No. 1 in D.

Their take on Shostakovich's lovably stumbling polka from "The Golden Age" — and its grasping toward a familiar form — felt freshly relatable; and likewise, their closing selection of "Toreador Song" from "Carmen" felt appropriately victorious for the occasion. After all, we'd made it!

Much like those nervously gathered to listen, the program was a little all over the place; but the intimacy of the experience — and our collective hunger to hear just about anything — gave the feeling that audience and performers were conducting the same experiment; just being there. Even before the first notes were played, I found myself getting lost in the music of chitchat and laughter — our own birdsong.

And while there were little reminders of the virus — the wiping down of musicians' seats between sets, the concerted effort to avoid touching the microphone, somewhat-matchy masks — it never overshadowed the evening. (The sun sails hung overhead did that, while helping keep the music contained from the roar of landing planes.)

For audience and musicians alike — and especially for Helms and her team, who found themselves immediately fielding questions about when the next concert will be (they're figuring it out) — the various tweaks, compromises and precautions required to realize something as simple as a night of music felt like a major achievement. I was tempted to high-five my neighbors in audience but, well, you know.

And it would enable at least some orchestra members to perform and some concertgoers to re-experience the joys of live music-making. These events might also offer opportunities to experiment with alternative onstage placements before moving to the next phase with a full symphony orchestra.

My wife and I, who live in the adjacent block, fully support your application. We believe this is an excellent use for the garden of this significant historic property and the classical music is something that can be enjoyed through open windows by the adjacent residents at the Sunrise Assisted Living, as well as paying guests from the neighborhood.

We have particularly enjoyed hearing the music waft out while walking past their garden on our weekend strolls. The volume is quite pleasant and does not intrude on the neighborhood. We can't hear them at all at our house.

I am very proud that through these concerts, Alexandria has emerged at the forefront of the resurgence of the arts, even as arts organizations and presenters in many other places have struggled to move forward. At a time when traditional indoor concerts remain impossible, I am grateful that Classical Movements has used their outdoor space to create a safe and comfortable environment to hear live music once again.

In our opinion, Alexandria does not do enough to support a local, thriving performance arts environment. We not only strongly support Classical Movements outdoor concerts, but we would encourage the city to make it easier for other venues to bring music, theater, and other arts to our neighborhood (I hear Blues Alley is looking for a new home).

I am very grateful for the opportunities Classical Movements has offered to our community to experience world-class music in an intimate and safe setting. I strongly encourage the Planning Commission to approve their application.

Dear Planning commission-

As Music Director of the Alexandria Symphony Orchestra and as a relatively new resident of Alexandria, I just needed to write to you expressing my full-throated support for the series of concerts that have taken place in Classical Movement's Secret Garden at the Rectory. I am James Ross and presently in my third season leading the ASO - one of the many Alexandria institutions and artists featured on CM's series this past fall. I have been both performer and audience member at a number of their events and I enthusiastically support their Special Use Permit Application #2020-00102.

As I'm sure you realize, the performing arts world has been particularly hard hit by the pandemic. Across the whole globe, live concerts in indoor venues came to a screeching halt last March. Concerts and livelihoods were snuffed out with no warning, and that situation has only very slowly begun to mitigate. At the ASO, we had to scrap our plans for the present season and, instead, we began offering small groups performing outdoor concerts at retirement communities, parks, and street fairs. The ASO is a fully professional orchestra made up of top notch free-lance musicians from across the DC region. We pivoted from presenting concerts with 80 musicians onstage (an orchestra) to a situation where the largest number of performers able to play safely for ASO events was 8.

The only concerts we have been able to offer with single ticket sales since last February were our October concerts at the Secret Garden. Covid concerns require us to rehearse and perform outdoors only and socially-distanced - not just the audience, but the performers spaced 6-feet apart as well. To sell single tickets, we needed a space that had protected egress and one that had good acoustics without requiring amplification. Thanks to this series being in operation, we were able to perform our hour-long concert mixing Beethoven with Tango four times over that October weekend with audiences of 42 at each concert. These concerts were crucial to the ASO's surviving this year of musical drought. Classical Movement's opening up their garden for live performances assured that all performers, audience members and staff could play in a safe and protected environment, and be reminded of the unique power of live music-making. Their series has been a lifeline for performing artists, including the ASO's, many of whom have had zero opportunities to earn their livelihood this past year.

I hope that the Planning Commission will take those factors into consideration and approve this Special Use Permit.

I am a resident of Alexandria writing in support of Classical Movements' Special Use Permit **#2020-00102.**

Throughout the years, Classical Movements has been an integral and important part of the City of Alexandria. Very few businesses have been more seriously disrupted during the pandemic than Classical Movements, which depends on both live performances and group travel for its livelihood. And yet during these challenging and unprecedented times, they continue to support and lend a helping hand to their community, the local music organizations and professional musicians, its partners, and local businesses.

As Board President of the Alexandria Symphony Orchestra, I can share our organization's first-hand experience of how vital it was to have a safe venue in which to perform four sold-out outdoor concerts this fall. These four concerts constituted the ASO's *only* ticketed events since the start of the pandemic. For these concerts, we hired eight ASO musicians and one guest artist for six engagements each (two rehearsals and four performances). For some of these musicians, this opportunity was one of their few paid gigs since last March. Classical Movements also hired some of our musicians for other performances there.

We greatly appreciate Classical Movements' support and admire their creativity in finding a way to present live music in a safe and outdoor venue. As an example of that creativity, the guest soloist at our concerts performed from a second-story balcony!

At a time when countless businesses in Alexandria are struggling to survive and, sadly, many others have shuttered, and as declining commercial tax revenue jeopardizes our city's ability to provide needed services and capital improvements, our city cannot afford to create obstacles for businesses that are at grave risk of closure. In certain sectors such as bars and restaurants, important accommodations have been made that have been essential to their livelihoods (such as using street space for outdoor dining, or allowing take-out of alcoholic beverages). This Special Use Permit is a reasonable accommodation that will allow Classical Movements to remain a vibrant business and community partner.
