










Covid Seating Map - Concerts/Weddings








Normal/Non-Covid Seating Map

I am writing to express my support for Classical Movements' Special Use Permit Application #2020-00102 for events at 711 Princess St.

My late Father was the Caretaker of the building at 711 Princess St. for some 30 years and as a young boy I often went with my Dad and played in the garden and got to know the property well. When I became older I often helped my father with his work at the property and in the garden, so it came as no surprise that I was hired as Caretaker in 1985 when my father passed away.

I have worked for the previous owner Rob Whittle of Williams Whittle all these years and when the building was sold in 2014 and Classical Movements moved in, I started working for them as well to assist with the maintenance of the property. I had also worked in the building on the grounds of 400 N Washington St. for several years until Sunrise bought this property.

As one of my tasks are is to ensure that the building is clean and the offices, bedrooms, bathrooms and kitchen are cleaned regularly, since the beginning of the pandemic, I have attended a training course for cleaning and sanitizing a property for Covid which came in very helpful for preparing the building and specifically the bathrooms before and during events. I have been trained even though the office had been closed since the beginning of March 2020. Classical Movements engaged me additionally on several weekends to sanitize and clean the building and help prepare for the concerts. I have appreciated this especially during the difficult period of this past year.

As someone who has worked in the building for so long, I was sorry but not surprised to hear about the complaint against the music – I have previously been subjected to the police being called on me by the same neighbor, for clearing the driveway of snow and often for otherwise simply fulfilling the duties of my job, working in the garden.

I understand that if outdoor concerts are not approved, there will be no other way to proceed with future performance in a safe way and the series will have to be cancelled entirely. This will be a loss to me personally and to the community as a whole, I regularly saw people I know from around the neighborhood who are happy to attend the concerts.

Dear Ann and Tony,

It was recommended today that we submit in writing our comments on the Staff report. Thank you for the opportunity. We are grateful for all that is being done to assist us by members of the Planning Commission. While we are mainly writing to comment on the conditions placed on us, we would like to first address the matter of acquiring a noise permit that we were offered as a solution.

Staff Report Page 3/4: As the next earliest City Council hearing was March 2021, P&Z coordinated with transportation and Environmental Services (T&ES) to allow for a temporary noise permit option. This was to allow Classical Movements the opportunity to continue to hold up to three already scheduled concerts, concluding at 8 p.m., with the approval of neighboring property owners prior to the March hearing. The business did not pursue this option, choosing instead to wait until the SUP hearings in March to learn if its SUP request would be approved prior to resuming outdoor concerts.

CM Reply: We feel this is not properly represented because even though it was an impossible goal (as you will see below,) we did pursue it and made a valiant effort in the bitter cold and during Covid. Yes, we were told that there was the possibility of being granted a temporary noise permit for the scheduling of some concerts (limited to one per month in Jan, Feb and Mar and to end by 8 pm!) but that we also needed to do the following: submit written statements from 100 percent of the neighboring properties stating support for our concerts (from Ann Horowitz) and submit a block party petition (from Lisa Goldberg), signed by each property owner or primary resident/business in the block, showing their agreement. We did start going door to door to obtain signatures of support, even though this was not a safe course of action for us during COVID and especially since one signature we needed was the complainant and hence the process was a non-starter. Nor were many residents at home and the main businesses were empty (Democracy Federal Credit Union and Sunrise for example totally empty in January and February). In particular, we went to 411 N Columbus St over 8 times in person and only once did the resident answer but said they had a migraine and to come back another time. We wrote about our efforts to obtain signatures in January but were told that in light of COVID-19 that only dropping off a letter at homes is sufficient and there was no need for us to knock on doors and speak faceto-face with individuals. This obviously contradicted what we needed to do to obtain a noise permit and caused much confusion. Ann Horowitz wrote to us that holding the concert on February 13 without a noise permit would lead to enforcement citations and that it may impact the Planning Commission and City Council reviews of our SUP, so we cancelled the event.

We feel strongly that apparently city rules require noise permits for amplification and for free events on public land. We were charging admission, we are not public land, and we do not have amplification. We feel it is also not correct to ask neighbors to sign off on a block party that requires the closing of the street when we were not doing that. Nor was it possible to get signatures without explaining that we needed them to sign something that in fact was not what was actually happening. This "solution" was something our business would have to do each

time we did a concert. This was an undue burden placed on our small, struggling business, in the freezing rain and cold, during COVID. Yet we tried.

As far as the Conditions on the SUP; We appreciate the recommendation that we be allowed to have outdoor events. We also appreciate the recommendation that we be allowed to have events like weddings and meetings and live concerts indoors. We are glad to have confirmation that we are allowed to have meetings and events inside our commercially zoned building. We disagree that we are not allowed to have live concerts outdoors.

We would be most grateful if consideration can be made for the following.

We disagree and strongly oppose the staff limitation on outdoor live entertainment. We are zoned CD. We feel that our unamplified, classical music concerts with very few musicians, is not noise. Further there are numerous other properties that the city supports (see the city website for event facilities) that allow outdoor live entertainment including amplified music such as dance bands and DJ's on private and public property. Our outdoor live entertainment impacts are limited and mitigated due to the location of our property. The acoustics of our garden courtyard are excellent and do not require amplification of the musicians.

RECOMMENDED CONDITIONS:

2. Indoor live entertainment, restaurant and outdoor dining are permitted on Saturdays and Sundays, between 10 a.m. and 10 p.m. All patrons must leave the premises at 10 p.m. (P&Z).

CM Reply: We request that we can arrange OUTDOOR and indoor live entertainment, restaurant and outdoor dining on any day of the week and not be limited to only two specific days of the week.

4. The maximum number of outdoor seats for outdoor dining shall be 50. City Council approval is required for an SUP amendment to increase outdoor seating over 50 for outdoor dining. (P&Z)

CM Reply: We request that the maximum number of OUTDOOR live entertainment, restaurant and outdoor dining shall we determined by the Fire Marshall and the State COVID-19 guidelines.

9. Unamplified, outdoor, limited live entertainment, serving only as background music for outdoor dining special events and consisting of one musician, may be offered and must comply with the City's noise ordinance. No admission or cover fee may be charged. All entertainment shall be subordinate to the principal function of the restaurant as an eating establishment. Any advertising of the entertainment shall reflect the subordinate nature of the entertainment by featuring food service as well as the entertainment. (P&Z)

CM Reply: We request that outdoor live entertainment not be limited to background music. Our primary use is for live entertainment so we also request not to have a limit on the number of musicians. We request that we can charge admission for the outdoor live entertainment. We request that outdoor live entertainment not be subordinate to the restaurant and outdoor dining. The restaurant and outdoor dining use is to support the outdoor live entertainment and other events. Almost all our concerts are without food and beverage. Our audiences, since we have started and still at the moment are all silent and masked. We need to advertise our outdoor live entertainment events.

10. The indoor live entertainment, restaurant and outdoor dining uses must comply with the city's noise ordinance. No indoor amplified sound shall be audible at the property line after 10:00 PM. (T&ES)

CM Reply: We request that we receive permission to have outdoor live entertainment as well.

14. The applicant shall provide information about alternative forms of transportation to access the site, including but not limited to printed and electronic business promotional

material, posting on the business website, and other similar methods. Contact Go Alex at goalex@alexandriava.gov for more information about available resources. (T&ES)

CM Reply: We request that we do not provide printed materials to reduce paper waste. Since we do not provide printed tickets, programs or instructions, we will include information about alternative forms of transportation to access the site through electronic materials and posting on our business website.

24. The maximum number of outdoor seats for live entertainment shall be 50. City Council Approval is required for an SUP amendment to increase outdoor seating over 50 for live entertainment. (P&Z).

We request that the maximum number of OUTDOOR live entertainment, restaurant and outdoor dining shall we determined by the Fire Marshall and the State COVID-19 guidelines.

25. Outdoor live entertainment is permitted on Saturdays and Sundays between 10 a.m. and 9 p.m. (P&Z)

CM Reply: We request that we can arrange OUTDOOR and indoor live entertainment, restaurant and outdoor dining on any day of the week and not be limited to only two specific days of the week. We also request that like other properties we are allowed to continue on rare occasions until 10pm.

26. The outdoor live entertainment use must comply with the City's noise ordinance. (T&ES)

CM Reply: We request that the SUP permit allows for unamplified outdoor live entertainment and that we are not denied use.

28. The applicant shall provide at least five-days prior notice to property owners, located one block of the business, of scheduled outdoor concerts and events. (P&Z)

We recommend that we provide a printed planned outdoor live entertainment schedule for all concerts to the neighbors within one block of our property once so that we can limit paper waste. After that we will inform the neighbors electronically. The notice will include contact information for them to send us their email address so that we can send updates if any changes. This information will also be updated on our website. We will also have the concerts advertised in postcards and kept in any info box in the front. We will also include the contact information of a designate community liaison to respond to property owners' questions and noise concerns.

City Code Requirements

3. Section 5-1-42- Collection by Private collectors. (c) Time of collection. Solid waste shall be collected from all premises not serviced by the city at least once each week. No collections may be made between the hours of 11:00 p.m. and 7:00 a.m. (6:00 a.m. from May 1, through September 30) if the collection area is less than 500 feet from a residential area. (T&ES)

We request that we can suspend service as needed when the office is empty and we have no live entertainment, restaurant and outdoor dining, or other events, to limit our expenses when the property has no use.

Since the beginning of the pandemic, I have attended a training course for cleaning and sanitizing a property for Covid which came in very helpful for preparing the building and specifically the bathrooms before and during events the events been trained even though the office has been closed, Classical Movements has engaged me additionally on several weekends to help prepare for the concerts. I have appreciated this especially during the difficult period of the past eleven months.

Dear Mayor Wilson and Members of Council:

I am writing to express my opposition to a Special Use Permit request (#2020-00102) from Classical Movements (CM) at 711 Princess St. They propose to turn their property into a concerts and event facility. My backyard patio is adjacent to their property. They have been having concerts this past spring and summer, and these events have significantly decreased the enjoyment of my home and patio throughout this time.

CM has been holding concerts nearly every weekend and doing so without a permit. (They claim to have contacted the City and not received an answer and therefore assumed a permit was not needed. (I was able to determine the need for such a permit with a single email to the City.)

At no time prior to holding these concerts did CM contact any of its neighbors. I only heard from CM after I complained to the City.

I can clearly and loudly hear these concerts in my back patio as well as in my home – and in the part of my home where my wife and I spend most of our time. Our kitchen and sunroom/family room are at the rear of the house. As you know, the Sunrise senior living facility is about to open. The residents on the south side of this building, adjacent to CM, will surely be affected by the proposed concerts, weddings, showers and other events, ending as late as 10 p.m., for which permission is requested.

You should also know that on more than one occasion, the owner of CM held a sign up toward my patio, while I was hosting guests, asking us to keep our voices down. I cannot imagine any of you would appreciate having someone ask you to keep quiet when all you are doing is having a conversation in your yard.

I have no problem with CM holding indoor events, as long as they cannot be heard outside their building. But I am also very concerned with the lack of parking for these events. CM claims to have made arrangements for remote parking, but why would anyone use that parking when they can conveniently park much closer on the street? The closest public facility is at the corner of Cameron and St. Asaph Street – hardly convenient. There is a parking lot at Wells Fargo across the street, but CM makes no mention of making arrangements with the bank to use its lot. CM also claims, wrongly, that most concertgoers are using Metro. I have watched people come to these events, and I can assure you I saw no one walking over. They were in cars, taking up scarce residential parking. As many as 40 people attended these events.

Should this permit be allowed to go through with outside events and no arrangements for parking at the Wells Fargo across the street, our ability to use our home to its fullest extent will be severely damaged. I believe such use will also decrease the value of my property. We have owned this house since 1987 and have loved living in it. That will no longer be the case should this SUP be granted. Please note that the lone letter of submission you have received is from a property owner who lives around the corner and 10 doors away from my house at 411. They are unaffected by CM's request.

Dear Chairman and Members of Planning Commission

I am writing in support of allowing Classical Movements to hold outdoor concerts for 50-56 people in the courtyard of 711 Princess Street. I had the pleasure of attending an Alexandria Symphony concert on the afternoon of last October 3, and thoroughly enjoyed the performance and the venue. The intimate courtyard setting (properly socially distanced of course) was totally different from the interior of a concert hall; it allowed a very different kind of performance, and left a lasting pleasant memory. As I sat in the courtyard I noticed that the Sunrise Senior Living is just adjacent and at that time already thought how lucky it was that the residents of that building would be able to hear beautiful concerts from their rooms. Having spent several months in the last two years visiting relatives in nursing homes, I can say with confidence that musical entertainment tends to be the highlight of the day for the elderly and infirm in such facilities.

While the music, even unamplified, may exceed the standards of the noise ordinance, it does not rise to the level of being a nuisance, particularly if the hours during which concerts are allowed are restricted to something like 10 am to 9 pm. Perhaps it is the noise ordinance that needs to be reviewed and changed, rather than this applicant being denied.

In summary, allowing unamplified outdoor concerts with limited seating and limited hours has many benefits: it helps keep a valuable business in business, provides enjoyable entertainment for Alexandrians, supports local artists and performing arts organizations, and as a bonus, provides soothing respite for Sunrise residents. This is quite a low-key and civilized activity, without rowdy crowds or loud music. This request should be approved, with the appropriate limitations on hours of operation.

This memorandum contains clarifying information on several topics related to Special Use Permit #2020-00102 at 711 Princess Street that arose at the Planning Commission briefings. These topic areas are outlined below.

A) Basis for approval recommendation for live entertainment

A Planning Commission recommendation of approval for outdoor live entertainment would acknowledge that the use would comply with the City's noise ordinance of 60 decibels at the shared property lines.

B) Proposed condition amendments

The applicant suggested they may consider scheduling events on weekdays (application page 29) and concerts on Federal holidays and weekdays (application page 28 and page 24, respectively). To accommodate scheduling flexibility, staff recommends allowing daily indoor and outdoor dining and indoor live entertainment as amended in Condition #2.

2. <u>CONDITION AMENDED BY PLANNING COMMISSION:</u> Indoor live entertainment, restaurant and outdoor dining are permitted on Saturdays and Sundaysdaily, between 10 a.m. and 10 p.m. All patrons must leave the premises at 10 p.m. (P&Z) (PC)

Staff recommends amending Condition #3 to add specificity to the building code reference.

3. <u>CONDITION AMENDED BY PLANNING COMMISSION:</u> The maximum number of indoor seats for the indoor live entertainment and the restaurant uses shall comply with the <u>Virginia Uniform sStatewide</u> building code. (P&Z) (PC)

After discussing this condition with the applicant, staff agrees to remove the limitation for one musician playing background music.

9. CONDITION AMENDED BY PLANNING COMMISSION: Unamplified, outdoor, limited live entertainment, serving only as background music for outdoor dining special events—and consisting of one musician, may be offered and must comply with the City's noise ordinance. No admission or cover fee may be charged. All entertainment shall be subordinate to the principal function of the restaurant as an eating establishment. Any advertising of the entertainment shall reflect the subordinate nature of the entertainment by featuring food service as well as the entertainment. (P&Z) (PC)

Similar to the rationale for amending Condition #2, staff recommends amending Condition #25 to include daily opportunities for live outdoor entertainment, should City Council choose to approve outdoor live entertainment.

25. <u>CONDITION AMENDED BY PLANNING COMMISSION:</u> Outdoor live entertainment is permitted on <u>Friday and</u> Saturdays between 10 a.m. and 9 p.m. and Sundays through Thursday between 10 a.m. and 8 p.m.-(P&Z) (PC)

C) Estimated decibel range for outdoor live entertainment

In the absence of actual sound measurements that take into account stage location and surrounding building structures as well as the background sound level, which staff had hoped to collect at concerts approved through a T&ES temporary noise permit prior to March 2021, staff estimates that the sound level for an outdoor concert at this location would most likely be in the range of 80-95 dB(A) measured at 10 feet. The decibel range is based on sound levels of different acoustic instruments on the attached table: https://www.daviddarling.info/encyclopedia of music/D/decibel.html.

Distances from proposed Stage 1 and Stage 2 to shared property lines range from ten feet (representing Stage 1 against the northern property line shared with Sunrise of Old Town) to approximately 60 feet (measuring from Stage 2 to the rear property lines of 409 and 411 North Columbus Street). Using the sound pressure versus distance formula, the sound level is calculated as 74-89 dB(A) at 20 feet from the stage, 68-83 dB(A) at 40 feet, and 62-77 dB(A) at 80 feet. Thus, considering the dimensions of the outdoor concert area and distances from the stage to the property lines, staff concludes that the associated sound levels of the proposed outdoor concert would most likely exceed the 60 dB(A) noise limit at the property line.

D) Conclusion

Staff continues to recommend partial approval of SUP #2020-00102 with amendments to Conditions #2, 3, 9 and 25.

Dear Planning Commissioners,

I am unable to make tonight's planning meeting to speak out against the Special Use Permit #2020-00102, 711 Princess Street, filed by Classical Movements. Please accept this correspondence into the record and take it into consideration when deliberating on the permit application.

I am the adjacent resident and property owner of 409 N Columbus Street. I currently object to the request as proposed due to the access during events to the rear of the property along shared right of ways adjacent to my property. During the past summer when Classical Movements held unpermitted events, attendees waited in lines along my property with a visual line of sight into my kitchen and other rear structure windows of my home. As an adjacent residential property with young children (ages 1 and 5) I also fear outside live entertainment and dining would exceed the noise ordinance of 60 dB(A). Staff recommends no outdoor entertainment, but I would also encourage the commission to include no outdoor dining during the times of 7 PM in the evening to 10 AM the following morning. I fear 50 seats of dining will also exceed 60 dB(A) based on outdoor dining observations with conversational talking and dining service movements. Lastly, the property on 711 Princess Street has only a single parking spot at the rear entrance of the outdoor space. The staff recommendation of maintaining agreements for only 7 off street parking spots is far from what would be needed for the proposed venue application based on the past years events. Street parking by attendees just exacerbates foot traffic along my (409 Columbus) southern and eastern property lines to gain access to the rear of the property's outdoor space. As a long time office structure, I request that the Alexandria Planning Commission deny the 711 Princess Street Special Use Permit #2020-00102 changing its function from a "9 AM to 5 PM" indoor office space to an indoor/outdoor restaurant and event venue.

Thank you for your time considering my objection and apologies for not being able to attend this evening's meeting. If you have any questions with regards this matter, please do not hesitate to ask.

I am respectfully submitting this to the Mayor, City Council and Members of the Planning Commission.

I am writing to express my opinions and concerns regarding the issues arising from the SUP request by Classical Movements. I do not know the founder or executive director of Classical Movements, but the issues being discussed in relation to their SUP have far ranging consequences for all arts programming in the city and need to be considered. As Producing Artistic Director of MetroStage (36 years) and in the process of building a new theatre in Old Town North that is designated an Arts Anchor in this Arts and Cultural District, I am deeply involved in the arts, trends affecting the arts, and the future of the arts.

Since COVID-19 shut down theatres and all other industries where people gathered in dangerously close contact, many creative solutions have arisen. Restaurants have outfitted outdoor dining which has become exceeding popular, and I believe will continue even after it is safe to return to indoor dining. (I am hoping that the temporary arrangement on lower King Street will continue as residents and tourists alike have embraced the concept.)

Theatres have gone virtual so a great deal of entertainment is being produced via zoom, streamyard and other platforms. Once theatres can safely reopen, I believe there will still be demand for virtual content. So theatres like restaurants are evolving with the times and challenges, and there is no turning back.

This brings me to Classical Movements where the same applies. Their concert tours ended, and they found a creative use of their property, especially the beautiful courtyard behind the building.

But now with considerable restrictions that use is limited. This is my concern because as historic as our beloved city is, we must move forward with the times, especially as it concerns the arts. With the many beautiful historic gardens in Old Town the opportunity for outdoor entertainment and concerts is extraordinary. A gift to the performing arts groups, residents and tourists. But there are restrictions on the books that may prevent this, and they must be reexamined.

In the case of Classical Movements it appears that nothing more than one musician providing background music is permitted under existing Codes. I would like to propose these Codes be reexamined to permit outdoor concerts in our city. Typically concerts range from 50 to 70 minutes long (at Classical Movements 60 minutes) and easily would end well before 10pm. Providing designated parking can be accomplished. And they would occur on weekends only (and possibly holidays), so how is this a problem in Old Town where most gardens are surrounded by commercial and occasional residential buildings?

Most would a agree that it enhances the neighborhood (as the surrounding building of Sunrise of Old Town has expressed). Ridiculously low decibel levels for outdoor music certainly need to be addressed since the construction equipment, trucks, airplanes etc don't seem to have to comply. Levels that compare to normal conversation are silly. Nobody goes to a concert to hear soft muffled music (BTW I am not advocating for rock bands. I am only concerned with the typical sound coming from a small group of musicians and a singer.)

So in sum I would ask that whatever Code is preventing Classical Movements from outdoor concerts should be reexamined by Council so that outdoor concerts can be offered by the many arts organizations offering live music, without so many constraints as to make it impossible. It serves everyone, both residential and commercial, as the applicant has pointed out---they use a local caterer, graphics business, etc. It serves the residents, attracts tourists, supports local businesses and keeps Alexandria on the map as an Arts Destination City. The arts provide culture but are also an economic engine for the City. I'm sure that Visit Alexandria would agree.

Thank you for your consideration, and I would welcome an opportunity to discuss further.
