Please deny live outdoor entertainment since it does not comply with City Code Ordinances Section 11-5-4 (b)(11) and Section 11-5-5 regarding the 60 dB(A) outdoor noise limit and prohibited noise next to nursing homes.

The Planning Commission modified approval conditions overlooked several city codes including City Code Sec. 11-5-4 (b) (11) related to noise next to nursing homes such as 400 N. Washington Street's Sunrise Senior Living for Assisted Living and Alzheimer & Memory Care Programs located adjacent to the applicant's property. The Sunrise garden, walking paths and outdoor space is part of their care per the Sunrise website:

"On our property, residents can enjoy the beautiful gardens, outdoor porches, and walking paths; all designed to offer opportunities to enjoy fresh air and nature throughout the day. Our residents will enjoy the close proximity to Waterfront Park and Founders Park as well as shopping and dining destinations."

Per the applicants site plan (see below site plan and seating chart maps submitted by applicant), the adjacent neighbor's property line and outdoor space is closer to the stage/music than concert attendee seats.

#### The City Code of Ordinances states:

Sec. 11-5-4 - Noises prohibited—enumeration.

(a) It shall be unlawful for any person to make, continue, or cause to be made or continued any excessive, unnecessary or unusually loud noise or any noise which unreasonably annoys, disturbs, injures or endangers the comfort, health, safety, welfare, or environment of others, within the limits of the city.

(b) The following acts, among others, are declared to be unlawful, but this enumeration shall not be deemed to be exclusive, namely:

(11) Schools, courts, churches, hospitals, nursing homes, public libraries. The creation of any excessive noise on any street adjacent to any school, institution of learning, church, public library or court while the same are in use, or adjacent to any hospital or nursing home which unreasonably interferes with the working of such institution or which disturbs or unduly annoys patients in the hospital or nursing home, provided conspicuous signs are displayed in such streets indicating that the same is a school, court, church, hospital, nursing home or public library.

#### Page 10 of the staff report states:

"The noise ordinance requirements of Section 11-5-5 of the City Code of Ordinances establishes the maximum decibel levels to be measured at the noise source's property lines. The maximum decibel level allowed at the property lines surrounding 711 Princess Street is 60 dB(A)."

Musical instruments cited by the applicant such as violins, quintet of horn players, quintet of string players, cello, oboe, trombone, trumpet decibels range between 80-114 (see below decibel charts). This music noise level:

- exceeds the 60 dB(A) noise level projected onto the adjacent properties outdoor space at 409 N. Columbus, 411 N. Columbus and 400 N. Washington Streets and does not comply with Section 11-5-5 of the City Code of Ordinances.
- exceeds the 60 dB(A) noise level, on a regular basis to run a new outdoor venue rental business for live outdoor entertainment, weddings, receptions etc., is excessive noise that would unreasonably interfere with the working of the nursing home, or disturbs or unduly annoys patients at Sunrise located at 400 N. Washington Street, therefore unlawful per Section 11-5-4 (b)(11) of the City Code of Ordinances.

Please deny the applicant's request for live outdoor entertainment since this request does not comply with City Code, and please uphold staff's original recommendation regarding it. Thank you.

Dear Ms. Sitton, please forward this to all members of Council for the March 13 hearing.

I am the arts editor for the Zebra Press publishing and media organization here in Alexandria. I attended a Classical Movements concert in the secret garden of the Christ Church rectory last fall. My article is linked below. Even as a writer I am unable to construct the words to adequately do justice to the joyfulness of the experience of once more hearing live music performed. The particular musical event I attended happened to be the first live choral music performed since the COVID pandemic began in the entire world.

The organizers of the event scrupulously maintained all COVID protocols. Masks were required, seating arrangements were by ticket and well beyond the 6-10 foot space requirements. Temperatures were checked before admission, at which point patrons were directed immediately to their seating. As ticketed patrons awaited their turn to be checked in and have their temperatures checked, social distancing parameters were maintained for those waiting down the driveway and barely onto the sidewalk. All the guests were quiet and respectful of the neighbors.

However, as the program began the neighbor over the fence to the back of the garden proceeded to engage in what can only be described as an impromptu party. This neighbor was far less respectful of the classical movement concertgoers' experience and the eloquent choral performances that he could have enjoyed for free. Their boisterousness was so disruptive I was at one point sorely tempted to climb on my chair, peer over the fence, and deliver a polite signal to shhhhhh. Fearing my fall would be more disruptive to the concert, I did my best to ignore the partygoers.

It is regrettable that this single neighbor failed to value the gift the Classical Movements bring to our community at a time when not only have such cultural experiences been curbed but hope itself has been challenged and at times all but quashed. As a 37-year-resident of Alexandria whose children are fourth generation Alexandrians and whose family roots hail back to Hachaliah Bailey of Bailey's Crossroads, I respectfully urge His Honor and Members of Council to grant the SUP permitting Classical Movements to operate their concerts indefinitely. As vaccinations become available we all look forward to the days ahead when we may gather together in friendship and community whether it be in schools, in places of worship, in theaters, or on both sides of a garden fence.

I am writing in support of Classical Movements' Special Use Permit #2020-00102 which

the Planning Commission approved at their March 2 meeting.

Throughout the years, Classical Movements has been an integral and important part of

the City of Alexandria. Very few businesses have been more seriously disrupted during the pandemic than Classical Movements, which depends on both live performances and group travel for its livelihood. And yet during these challenging and unprecedented times, they continue to support and lend a helping hand to their community, the local music organizations and professional musicians, its partners, and local businesses. As Board President of the Alexandria Symphony Orchestra, I can share our organization's first-hand experience of how vital it was to have a safe venue in which to perform four sold-out outdoor concerts this fall. These four concerts constituted the ASO's only ticketed events since the start of the pandemic. For these concerts, we hired eight ASO musicians and one guest artist for six engagements each (two rehearsals and four performances). For some of these musicians, this opportunity was one of their few paid gigs since last March. Classical Movements also hired some of our musicians for other performances there.

The ASO greatly appreciates Classical Movements' support and admire their creativity in finding a way to present live music in a safe outdoor venue. As an example of that creativity, the guest soloist at our concerts performed from a second-story balcony! At a time when countless businesses in Alexandria are struggling to survive and, sadly, many others have shuttered, and as declining commercial tax revenue jeopardizes our city's ability to provide needed services and capital improvements, our city cannot afford to create obstacles for businesses that are at grave risk of closure. In certain sectors such as bars and restaurants, important accommodations have been made that have been essential to their livelihoods (such as using street space for outdoor dining, or allowing take-out of alcoholic beverages). This Special Use Permit is a reasonable accommodation that will allow Classical Movements to remain a vibrant business and community partner. Again, on behalf of the Alexandria Symphony Orchestra, I strongly support Classical Movements and their Special Use Permit application. As a related matter, I urge the Council to move forward with a review and update of the current noise ordinances, which played a role in the difficulties that have been inflicted upon Classical Movements.

Dear Mayor Wilson and Members of City Council:

I am writing to request the City Council's consideration of the following amendments to the Staff Recommended Conditions in the Special Use Permit application before you for approval at Saturday's Public Hearing.

1. Amendment to Condition #1 to add as a Co-Permittee Musical Movements for Change, Inc. an independent IRS tax exempt nonprofit corporation organized by the Applicant to advance the arts. Musical Movements for Change, Inc. will, in addition to the Applicant, organize and hold Concerts. The amended condition would read:

"The Special Use Permit shall be granted to the applicant and Musical Movements for Change, Inc, only or to any business or entity in which the applicant or Musical Movements for Change, Inc. has a controlling interest.

2. Condition #4 should be deleted if the City Council approves Outdoor Live Entertainment. Condition 24 would govern the maximum number of seats for Outdoor dining seats and Outdoors Live Entertainment seats. Condition #24 should be amended to add the words "outdoor dining seats". Revised Condition #24 would read:

"The maximum number of outdoor dining seats and the maximum number of seats for live entertainment shall comply with the Virginia Uniform Statewide Building Code".

3. Amendment to Condition # 25 to allow for the seasonal adjustments to extend the ending hour that Outdoor Live Entertainment is permitted for the months of March to September from 10 a.m. and 9 p.m. seven days a week. During the months of October to February the permitted hours would not change from the hours in Condition #25 as written. Amended Condition #25 would read:

"Outdoor Live Entertainment is permitted between the hours of 10 a.m. and 9 p.m. seven days a week during the months of March through September and 10 a.m. and 9 p.m. on Friday and Saturdays and 10 a.m. and 8p.m. on Sunday through Thursdays during the months of October through February".



4 Amendment to Condition #28 to provide that written notice shall be required to be sent to abutting property owners as defined in the Zoning Ordinance rather than property owners within one block of the business. This amendment is consistent with the notification requirement of all public hearings. Amended Condition #28 would read:

"The applicant shall provide at least five-days prior notice to abutting property owners as defined in the Zoning Ordinance of scheduled outdoor concerts and events".

Dear Mr. Mayor and Members of the Council:

Being unable to participate at the hearing next Saturday in the above matter, I ask your leave to submit these comments for the record. The Planning Commission would grant a special exemption to—quite literally—blow through the longstanding laws of this City that protect the peace and tranquility of residential neighborhoods.

The applicant demands entitlement to blast music (of whatever sort) and cater outdoor gatherings whenever it chooses, and the neighbors be damned. The City Code sets a limit of 60 decibels (which is already loud). The Planning Commission did not enforce that.
The City Staff proposed limits in keeping with the laws and traditions of the neighborhood and the City Code. The Staff advised the Planning Commission that

"Given the significant likelihood that live outdoor concerts would exceed the noise ordinance of 60 dB(A) at the shared commercial and

residential property lines, the location is not considered appropriate for the live outdoor entertainment use, and staff does not recommend

approval of this specific SUP request."

The Planning Commission, unaccountably, went completely off the rails, scolded the Staff, and essentially ruled that, anything goes.

This proposal has proceeded on a stealth basis; very few people learned of it. Today the Alexandria Times for whatever reasons ran two misleading articles boosting the project, never bothering to speak to anyone opposed to it, ignoring the scope of the proposal, and implying that only one individual had any objection. On the contrary, those of us who are in range and who object—and at the noise level contemplated here, it is a big, big range—are legion. Nor is this a matter of quiet classical melodies. The repertoire of the applicant business, in spite of its name, tends often to the loud and sometimes bizarre, and anything these days is called a "concert"—not to mention what we all know gets played at well-lubricated wedding receptions and bar mitzvahs, which do not appear excluded. The Planning Commission, thumbing its nose at the Staff and the City Code, decided essentially to place no meaningful limits on anything.

This proposal has nothing to do with COVID. Those restrictions will all be gone in a few weeks or months, and will not impose any restraint on this commercial venture or others. There will be many alternative locations available for such activities. A sophisticated public-relations plan has generated supporting letters from show-biz friends all over the country, but you will find few from the Alexandrians affected.

Worst of all—you can't make this stuff up—they want to entrench their unlimited activities exactly next door to the elderly residents of the Senior Living facility that is smack-dab beside the property line. The residents will be able not only to absorb the sounds without their hearing aids, but can stare out their windows (in a community where they thought they were purchasing some peace) to observe whatever carousing the misnamed Classical Movements, armed with a no-limits Special Use Permit, decides to host.

Please bring back the sanity that the Planning Commission lost, respect the good judgment of the Staff, and disapprove the Planning Commission's action.

SUBJECT: DSUP #2020-10027 / BRADDOCK WEST

#### ISSUE:

The applicant and staff have been coordinating since the deferred City Council hearing in December 2020 to address and come to agreement on conditions related to (1) the valuation of two public alleys included in the site based on the 2004 City Vacation memo; and (2) connection to the Potomac Yard Trunk Sewer and related costs. Staff supports the Braddock West project but cannot support deviations from established City policies and priorities, which could have long-term impacts on projects across the city. Staff finds that compliance with the conditions of approval related to the issues discussed and recommended below is fair and reasonable, in addition to being consistent with other DSUP approvals, including specifically within the Braddock Metro Neighborhood.

#### Valuation of Vacation

- The DSUP application includes a request to vacate two public alleys as part of this project.
- Previously, the applicant asserted that the alleys were private. Researching City records, including maintenance records dating to 1977-78, has confirmed the alleys are public by charter.

The Office of Real Estate Assessments (OREA) has assessed the fair market value of the two public alleys (totaling 2,724 square feet) based on the site rezoning to OCH and the alleys' use for buildable site area utilized for the proposal building footprint, consistent with the 2004 City Vacation Policy. OREA has calculated that 11 dwelling units within the project are attributed to the vacation and future consolidation of the public alleys into the site. OREA originally provided an initial assessment based on the weighted mean land value of the units derived from the alley consolidation, valuing the alleys at a fair market value of \$1,000,000. OREA has since revised the estimated value due to atypical development costs related to required sanitary sewer improvements. OREA estimates the fair market value of the two vacated alleys to be \$643,500 to \$660,000, a range based on the estimated full cost to provide sanitary sewer to the property. Should the applicant not be responsible for funding the full cost of the sanitary sewer improvements themselves, the valuation would increase as that discount would no longer be applicable.

Staff recommends that the applicant pay \$650,000, based on the development rights and atypical costs associated with this vacation, to the City Open Space Fund, as recommended in the City Vacation Policy.

#### Sanitary Sewer

- The BMNP specifically states that all sites in the Braddock Metro Neighborhood Plan (BMNP) area will connect to the Potomac Yard Trunk Sewer (PYTS). It should be noted that the requirement to connect to the PYTS has been in place since the 2008 BMNP was adopted.
- The City determines where and how properties connect to the City's sewer system and property owners are required to construct such connections at their own expense.
- If a property owner constructs a connection that exceeds the requirements for their property, the City may provide credits that offset the sewer tap fee based on the cost.
- The applicant's current proposal to pay a pro rata share of the costs of construction do not comply with the City Code. However, the proposed City conditions provide a credit for constructing sewer infrastructure beyond what is required for this project in conformance with the City Code.

The PYTS, constructed in 2002, was designed to accommodate flows from areas outside Potomac Yard and is consistent with the City's 2012 Sanitary Sewer Master Plan. One of these areas is the Commonwealth Sewershed. During significant wet weather events, both the Commonwealth Interceptor and City-owned collector sewers that connect to the Commonwealth Interceptor, operate over capacity, potentially leading to sanitary sewer back-ups in homes and businesses. The project site currently connects to the Commonwealth Interceptor. Homes that connect to the City sewers downstream of the project site experienced sanitary sewer back-ups earlier this year during the wet weather events on July 23 and September 10. To date, all development projects in the plan area have connect to the PYTS. Along with the plan requirement, the applicant was informed about the requirement to connect to the PYTS since the first concept plan was submitted in 2017. Therefore, staff is requiring the project to connect to the PYTS pursuant to Condition 68.

Staff has identified offsite areas next to the project site (sanitary sewer on N. West Street) that can be connected to the applicant's proposed sewer, further reducing flows to the Commonwealth Interceptor. Staff Condition 69 provides an opportunity for tap fee credits if the applicant connects offsite areas from the Commonwealth Interceptor to the PYTS and upsizes their proposed sewer from a 10-inch to 12-inch sewer to accommodate the offsite flows. Staff has reviewed City Code Section 5-6-25.1(b) and has determined that sewer tap fee credits cannot be provided for projects that only meet their minimum sewer connection requirements. Tap fee credits can only be provided for projects that exceed their minimum requirements. Only the costs associated with the connection of these offsite areas would be subject to tap fee credits, along with the cost of upsizing their proposed sewer from a 10-inch to 12-inch pipe. Condition 69 provides opportunity for this credit and allows for the project to move forward. Staff will continue to work with the applicant to determine the tap fee credit amount for constructing the larger pipe as well as the additional infrastructure, should the applicant wish to pursue the connection of offsite areas.

Staff is proposing that Condition 69 be amended as written below, which requires the applicant to upsize their proposed sewer from a 10-inch to 12-inch pipe, regardless of any offsite connections, to allow for future connections. The applicant will be entitled for sewer tap fee credits pursuant to Section 5-6-25.1(b)(2).

The applicant has proposed, in a letter dated February 26, 2021, changes to Conditions 68 and 69 based on its pro rata share of the total cost of the sewer construction, which is estimated at \$1.8-\$2.0 million.

The applicant has stated that their pro rata share is approximately 25 percent of this cost and are proposing that credits to the sewer tap fee (estimated at \$1.5 million) be provided for costs above their pro rata share. The applicant proposes that the City could recoup this tap fee revenue through charges to future development projects as part of the DSUP process. Staff has reviewed the City Code and sewer tap fee credits are not provided for based on a pro rata share methodology. For this reason, staff has not confirmed the applicant's calculations to determine what, if any pro rata share would be appropriate. In order to allow for tap fee credits based on this methodology, the City Code would need to be amended. In addition, staff does not have any mechanism to charge future development for connecting to sewer infrastructure that would already be constructed, beyond our existing tap fees. Any change to the City Code to allow a pro rata share for construction of required sewer infrastructure would likely lead to increased cost to the City for providing infrastructure required to support development. Such changes may have further unintended consequences and would require detailed study by staff.

# Staff is recommending that Council approve the staff conditions and not approve the alternative condition language proposed in the February 26<sup>th</sup> letter.

#### **UPDATED CONDITIONS:**

In addition to condition 69 mentioned above, staff requests City Council recommend approval of the minor conditions changes below. For Condition 2, the City Council Legislative Meeting date where the DSUP approval validity period was extended based on the COVID-19 pandemic has been updated. Staff is also requesting amendments to conditions 77 and 78 to clarify the number of trash and recycling receptacles to be provided are per the site and not per blockface. The changes to conditions 77 and 78 were mistakenly omitted from the Planning Commission recommendation action.

- 2. Per Section 11-418 of the Zoning Ordinance, the development special use permit shall expire and become null and void, unless substantial construction of the project is commenced within 36 months after initial approval (<u>plus any extensions per the ordinance adopted by City Council on December 12, 2020 as Temporary Program for Business Relief and to Address Public Need Related to COVID-19<del>plus any extensions per the July 7, 2020 City Council Docket Item 19 due to the COVID-19 <u>emergency</u>) and such construction is thereafter pursued with due diligence. The applicant shall provide a written status report to staff 18 months after initial approval to update the City Council on the project status if substantial construction has not commenced at such time. The period of validity may be extended upon petition by the applicant and after adequate notice and public hearing. (P&Z)</u></del>
- 69. The applicant shall be provided with a credit to be applied towards the sanitary tap fee, if the applicant connects offsite sanitary flow that currently discharges to the Commonwealth Interceptor, to the proposed sanitary sewer serving the development, which shall connect to the Potomac Yard Trunk Sewer. Based on separating the existing 8 inch sanitary sewer on N West Street, the tap fee credit shall not exceed \$600,000 unless otherwise mutually agreed upon by the applicant and the City. The applicant shall be responsible for determining the feasibility of such connection(s) prior to the first Final Site Plan submission. (T&ES) \*

- 69. The applicant is required to install a 12-inch sanitary sewer from their project site to the Potomac Yard Trunk Sewer; this exceeds the requirement to provide service to the property of a 10-inch sanitary sewer. The applicant shall be provided a sewer tap fee credit for the installation of the 12-inch sanitary sewer versus the 10-inch sanitary sewer in accordance with the City Code. In addition, the applicant shall be provided with a sewer tap fee credit for the connection of any offsite sanitary sewers, including the existing 8-inch sanitary sewer on N West Street. The applicant shall be responsible for determining the feasibility of such connection(s) prior to the first Final Site plan submission. (T&ES)
- 77. Provide \$1402 per receptacle to the Director of T&ES for purchase and installation of one (1) Victor Stanley Ironsites Series model SD-42 black receptacle with Dome Lid per block face-dedicated to trash collection. The receptacle(s) shall be placed in the public right of way to serve open space and park sites. Receptacles shall be generally located along the property frontage and at strategic locations in the vicinity of the site as approved by the Director of T&ES. Payment required prior to release of Final Site Plan. (T&ES) \*
- 78. Provide \$1626 per receptacle to the Director of T&ES for the purchase and installation of three (3) Victor Stanley Ironsites Series Model SD-42 blue receptacle with Dome Lid, approved dome decals, and approved band per blockface dedicated to recycling collection. The receptacle(s) shall be placed in the public right of way to serve open space and park sites. Receptacles shall be generally located along the property frontage and at strategic locations in [AB1] [AB2] [AB3] the vicinity of the site as approved by the Director of T&ES. Per your request, we have reviewed the proposed vacation of two pubic alleyways located on the east side of North West Street between that artery's intersection with Madison Street and Wythe Street across from the Braddock Road Metro Station. They are primarily asphalt-paved measuring 11.58 feet wide by 107.1 feet (Southwest Alley) and an average of 120.71 feet deep (Northwest Alley). Both are recoded among the City land records within Deed Book 88, at Page 152. They contain a combined land area of 2,724 square feet (1,244 SF Southwest Alley; 1,480 SF Northwest Alley) and are part of a proposed development plan (DSUP 2020-10027) by West Street Acquisitions LLC to rezone (REZ 2020-0004) 41,398 square feet from RB to OCH for the development of 180 multi-family rental units with ground floor retail and flex space. Fourteen of the 180 units will be developed and maintained as affordable, leaving 166 market rate units. The project will be known as Braddock West. The land area of both alleys were used in the calculation of density (number of units).

Neither of the alleyways can be individually developed, and assemblage with the redevelopment of single-family uses does not constitute the highest and best use. It would also be contrary with recommendations within the Braddock Road Metro Station Small Area Plan which envisions redevelopment of higher density hotel or office uses with streetscape neighborhood retail. Given the lack of demand for either hotel or office, the redevelopment with mixed-use multi-family represents the current highest and best use. As such, the West Street Acquisitions LLC is requesting a Master Plan Amendment (MPA 2020-00008) for this type of development.

The value of the proposed vacation was estimated using the CY 2021 assessed land values of stick built midrise multi-family parcels in the immediate neighborhood and those that possess similar characteristics located elsewhere in the City. It has been OREA's experience that affordable dwelling unit land values are essentially revenue neutral. In other words, their value in isolation from the market rate units closely approximate the hard and soft costs to construct the improvement components. Recent multi-family land sales were also used in the analysis.

Research indicates that assessments and recent sales range from \$68,000 per unit to \$90,700 per unit. However, unlike other projects the subject will incur additional site development costs ranging from \$1,750,000 to \$2,000,000 in order to provide sanitary sewer to the property. These additional costs act to place significant downward pressure on the per unit rate. Given all the factors that impact the economic feasibility of this property relative to site development, the OREA is of the opinion that an as-is assessed value of \$58,500 per unit to \$60,000 per unit is reasonable. Using a proportional relationship of units to acreage, it is estimated that the two alleyways will support 11 of the proposed 180 multi-family units.

Based on the foregoing discussion, the proposed vacation of the two alleyways have a combined prospective estimated assessment ranging from \$643,500 (11 units x \$58,500 per unit) to \$660,000 (11 Units x \$60,000 per unit).

#### <u>Six Hundred Forty-Three Thousand Five Hundred Dollars</u> to Six Hundred Sixty Thousand Dollars

This analysis does not constitute a fully documented real property appraisal report and should not be purported as such. The analysis is based on 2021 assessed land values of similarly zoned parcels intended for multifamily development and complies with City policies and guidelines regarding vacations.

Dear Gloria,

I am a current employee of Classical Movements. Since the pandemic began almost a year ago today, our work evaporated within a few short weeks.

With no income and nothing to do, we needed to be creative. My company was the first in the country to host socially-distanced concerts in our Garden. It was an inspired project done with care and safety. It brought joy to the staff to be working on musical projections again but also joy to the audiences that attended who had been stuck at home for 3 months. With so many restrictions by the state, indoor music venues have ceased to exist. We were able to utilize our property to bring music and happiness to people who desperately needed it.

Here we are a year later and much has not improved. While Covid cases are decreasing and vaccines are being distributed, most indoor music venues still won't open until summer or fall. Our concerts are important for the audiences and our community as a needed reprieve from the day to day struggles of living in a pandemic. The performers also need us, who have had virtually no performances or income this year except for the ones they performed with us. Can you imagine studying for over 20 years perfecting your craft, to then be completely left without a job and no one wants to help you. If you restrict our

concerts, that is what you will continue to do.

Music is not noise and shouldn't be restricted in our Garden. When I would sit in our Garden during my lunch break pre-pandemic, I would hear actual noise: construction from neighboring buildings, lawns being mowed, cars zooming by on Washington Street and Princess Street, airplanes flying overhead. Even the birds are louder that some of our performers.

Please don't restrict music for my company and our audiences. Until live music resumes to what it once one, these small performances is all this community has. A true music lover knows, there is no language quite like it. It brings people together with a common interest. The love for it doesn't need to be discussed. You can feel it. You can feel the energy in the room just before a concert starts and after it ends. People need music now more than ever and need to experience joy and community in the few ways possible.

Dear Mayor Wilson and Members of Council:

I am writing to express my opposition to a Special Use Permit request (#2020-00102) from Classical Movements (CM) at 711 Princess St. They propose to turn their property into a concerts and event facility. My backyard patio is adjacent to their property. They have been having concerts this past spring and summer, and these events have significantly decreased the enjoyment of my home and patio throughout this time.

CM has been holding concerts nearly every weekend and doing so without a permit. (They claim to have contacted the City and not received an answer and therefore assumed a permit was not needed. (I was able to determine the need for such a permit with a single email to the City.)

At no time prior to holding these concerts did CM contact any of its neighbors. I only heard from CM after I complained to the City.

I can clearly and loudly hear these concerts in my back patio as well as in my home – and in the part of my home where my wife and I spend most of our time. Our kitchen and sunroom/family room are at the rear of the house. As you know, the Sunrise senior living facility is about to open. The residents on the south side of this building, adjacent to CM, will surely be affected by the proposed concerts, weddings, showers and other events, ending as late as 10 p.m., for which permission is requested.

You should also know that on more than one occasion, the owner of CM held a sign up toward my patio, while I was hosting guests, asking us to keep our voices down. I cannot imagine any of you would appreciate having someone ask you to keep quiet when all you are doing is having a conversation in your yard.

I have no problem with CM holding indoor events, as long as they cannot be heard outside their building. But I am also very concerned with the lack of parking for these events. CM claims to have made arrangements for remote parking, but why would anyone use that parking when they can conveniently park much closer on the street? The closest public facility is at the corner of Cameron and St. Asaph Street – hardly convenient. There is a parking lot at Wells Fargo across the street, but CM makes no mention of making arrangements with the bank to use its lot. CM also claims, wrongly, that most concertgoers are using Metro. I have watched people come to these events, and I can assure you I saw no one walking over. They were in cars, taking up scarce residential parking. As many as 40 people attended these events.

Should this permit be allowed to go through with outside events and no arrangements for parking at the Wells Fargo across the street, our ability to use our home to its fullest extent will be severely damaged. I believe such use will also decrease the value of my property. We have owned this house since 1987 and have loved living in it. That will no longer be the case should this SUP be granted. Please note that the lone letter of submission you have received is from a property owner who lives around the corner and 10 doors away from my house at 411. They are unaffected by CM's request.

Thank you for your consideration of my request.

Ladies and Gentlemen:

As Executive Director of the Alexandria Symphony Orchestra, I am writing in support of Classical Movements and their extraordinary efforts to bring live classical music back to our community with their outdoor concerts at The Rectory on Princess.

Live music performed in person is the heartbeat of our cultural life. In normal years, the ASO reaches over 40,000 people in our region; due to the pandemic for the past 12 months all of our indoor events have been curtailed.

In the midst of this pandemic-imposed musical atrophy, Classical Movements took the lead in offering opportunities for musicians to perform by creating an innovative series of outdoor socially-distanced events. This activity has served as a lifeblood to local musicians, including many who had been depending on ASO for employment.

The current city noise limit of 60 decibels is approximately the level of common street noise in that area; voice conversation brings that level up to 75db. Small classical groups barely exceed conversation levels. The City makes frequent exceptions to the noise ordinance when the benefits of the activity outweigh the negative effects of the "noise"—if one can call a Beethoven string quartet noise.

How important is live classical music to Alexandrians? In 1943 at the height of World War II Alexandria was deeply involved in the war effort, supporting the completion of the Pentagon and creating the housing necessary to bring thousands of military personnel to Alexandria. Remarkably, Alexandrians chose that challenging moment to found the Alexandria Symphony Orchestra, now 78 years strong. Classical Movements is furthering that heroic commitment of our predecessors.

The efforts of Classical Movements to support live music in our current time of extraordinary challenge are to be supported and encouraged. We at ASO do so unreservedly, and ask the Council to allow these fine corporate citizens the opportunity to continue to enrich the cultural lives of Alexandrians.

These events have become a coveted and beloved aspect of the renewed and unparalleled ambience of the Alexandria area.

I have attended these concerts myself, and the music and performances executed by Classical Movements are not in any way loud or intrusive presentations, they are perfectly suited for the location, they are masterful and magical, and they are part of the everlasting beauty and creative presence of Alexandria itself. The bottom line? They make life better.

At a time when traditional indoor concerts continue to remain largely impossible, I am grateful that Classical Movements has used their outdoor space to create a safe and comfortable environment to hear live music once again. I think it is a huge accomplishment that through these concerts, Alexandria has emerged at the forefront of the resurgence of the arts, all as other arts organizations and other businesses in Alexandria and around the country continue to suffer due to the pandemic. I am respectfully submitting this to the Mayor, City Council and Members of the Planning Commission.

I am writing to express my opinions and concerns regarding the issues arising from the SUP request by Classical Movements. I do not know the founder or executive director of Classical Movements, but the issues being discussed in relation to their SUP have far ranging consequences for all arts programming in the city and need to be considered. As Producing Artistic Director of MetroStage (36 years) and in the process of building a new theatre in Old Town North that is designated an Arts Anchor in this Arts and Cultural District, I am deeply involved in the arts, trends affecting the arts, and the future of the arts.

Since COVID-19 shut down theatres and all other industries where people gathered in dangerously close contact, many creative solutions have arisen. <u>Restaurants</u> have outfitted outdoor dining which has become exceeding popular, and I believe will continue even after it is safe to return to indoor dining. (I am hoping that the temporary arrangement on lower King Street will continue as residents and tourists alike have embraced the concept.)

<u>Theatres</u> have gone virtual so a great deal of entertainment is being produced via zoom, streamyard and other platforms. Once theatres can safely reopen, I believe there will still be demand for virtual content. So theatres like restaurants are evolving with the times and challenges, and there is no turning back.

This brings me to Classical Movements where the same applies. Their concert tours ended, and they found a creative use of their property, especially the beautiful courtyard behind the building.

But now with considerable restrictions that use is limited. This is my concern because as historic as our beloved city is, we must move forward with the times, especially as it concerns the arts. With the many beautiful historic gardens in Old Town the opportunity for outdoor entertainment and concerts is extraordinary. A gift to the performing arts groups, residents and tourists. But there are restrictions on the books that may prevent this, and they must be reexamined. In the case of Classical Movements it appears that nothing more than one musician providing background music is permitted under existing Codes. I would like to propose these Codes be reexamined to permit outdoor concerts in our city. Typically concerts range from 50 to 70 minutes long (at Classical Movements 60 minutes) and easily would end well before 10pm. Providing designated parking can be accomplished. And they would occur on weekends only (and possibly holidays), so how is this a problem in Old Town where most gardens are surrounded by commercial and occasional residential buildings?

Most would a agree that it enhances the neighborhood (as the surrounding building of Sunrise of Old Town has expressed). Ridiculously low decibel levels for outdoor music certainly need to be addressed since the construction equipment, trucks, airplanes etc don't seem to have to comply. Levels that compare to normal conversation are silly. Nobody goes to a concert to hear soft muffled music (BTW I am not advocating for rock bands. I am only concerned with the typical sound coming from a small group of musicians and a singer.)

So in sum I would ask that whatever Code is preventing Classical Movements from outdoor concerts should be reexamined by Council so that outdoor concerts can be offered by the many arts organizations offering live music, without so many constraints as to make it impossible. It serves everyone, both residential and commercial, as the applicant has pointed out---they use a local caterer, graphics business, etc. It serves the residents, attracts tourists, supports local businesses and keeps Alexandria on the map as an Arts Destination City. The arts provide culture but are also an economic engine for the City. I'm sure that Visit Alexandria would agree.

Thank you for your consideration, and I would welcome an opportunity to discuss further.

I am a long-time professional musician and writer: During my three decades with the Minnesota Orchestra I closely observed Neeta Helms and her team at Classical Movements. Her dedication and the energy she has put into bringing high-quality music to communities who may not otherwise have the benefits of hearing performances is quite astonishing. But she also brings communities together--students and amateurs, as well as professionals--to perform with and for other cultures in our country and beyond.

At a time when people yearn for music, and connection, we need people like Ms Helms who has come up with creative solutions to the barriers, isolation, and lack of interaction we are experiencing due to the dangers of the covid virus. When I heard about her chamber music concerts, which took place in their lovely garden at the Rectory on Princess Street, strictly and carefully planned and regulated, I thought it was a brilliant idea. The people who attended these programs were thrilled and the programs sold out quickly.

I have heard that the City of Alexandria is mandating a Special Use Permit for the outdoor concerts that Classical Movements has presented. As someone who has published articles about noise and hearing issues, street traffic, rock music piped outside, leaf blowers, and games of sports are well over the decibels that a chamber music ensemble produces. A small group of classical musicians is not noise, especially in an intimate setting.

I believe your community needs these programs: we need to be able to safely gather, contemplate, celebrate, lose ourselves and our troubles if for only an hour, in music, while we wait to able to return to some kind of normalcy. This is the only safe way to present live music at this time. This is the only way musicians can currently continue to perform.

As word spreads of Alexandria's ability to innovate and safely lean in to support the arts, greater economic prosperity will likely follow.
