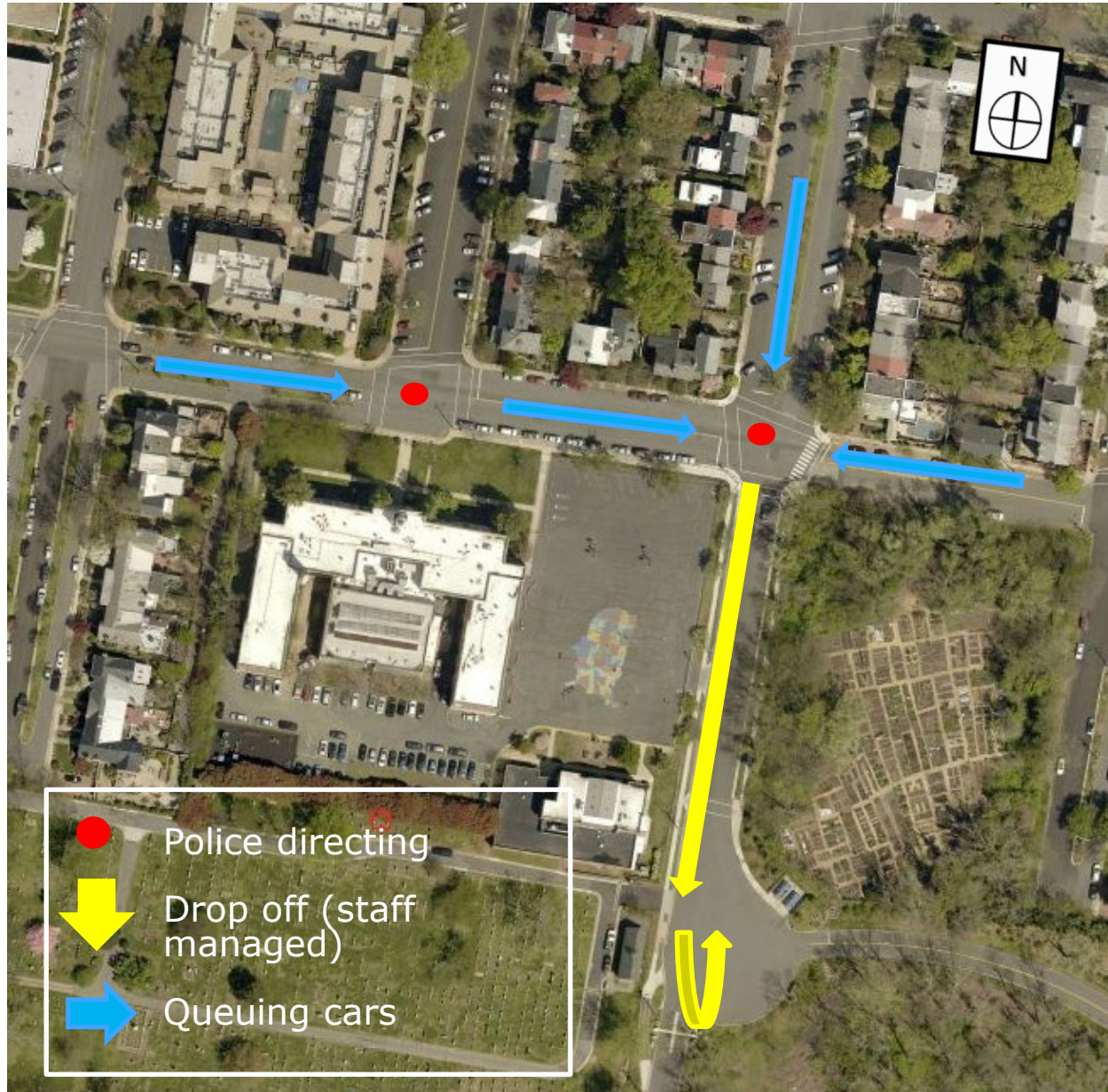

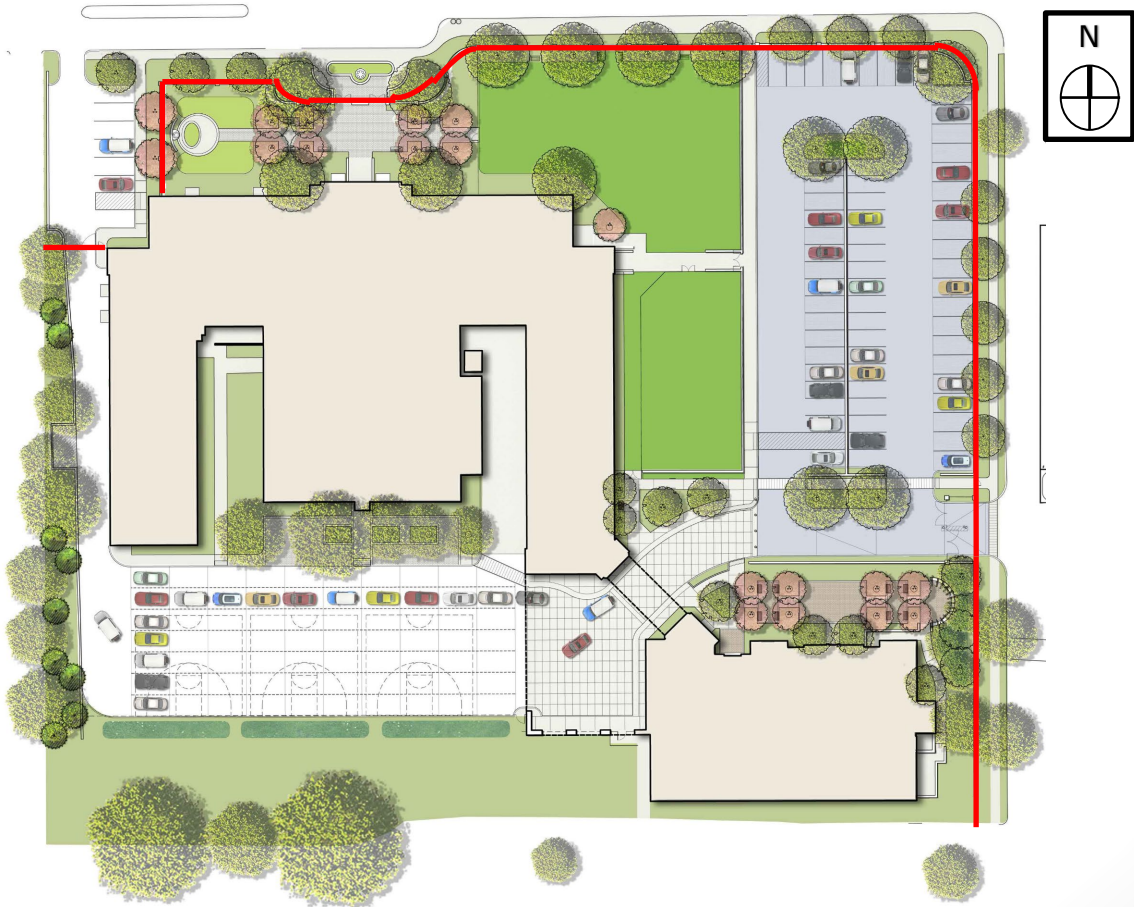
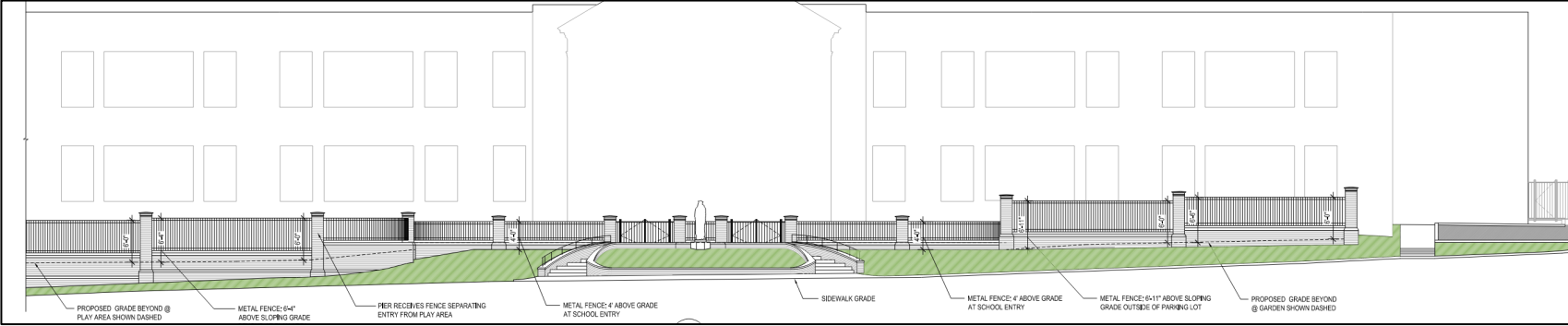

# SUPs and Modifications

## Special Use Permits (SUPs)

- Development SUP and site plan to expand an existing private school
  - Increased enrollment
  - Addition
  - Site improvements
- Exceed the maximum parking requirement

## Site Plan Modifications

- Street tree placement requirement in the Landscape Guidelines
- Modification to the minimum landscape island requirement

# Compliance with Master Plan and City Policies

- Continued “institutional use” per the Old Town Small Area Plan
- 2019 Green Building compliant
- Landscape Guidelines compliance, with modifications to street tree placement and landscape islands
- BAR endorsed concept plan

# Updated Condition #13

13. The project shall comply with the requirements defined by the City of Alexandria 2019 Green Building Policy using the LEED BD&C Schools rating system and will achieve the equivalent of LEED Silver certification for the addition, except that the Applicant may use the Policy's alternative path of independent third-party certification to confirm that the requirements set forth below have been met. Diligent pursuance and achievement of certification shall be monitored through the following:
- f. Provide evidence of the project's registration with LEED or the use of a third-party certifier prior to, ~~Green Globes or Earthcraft (or equivalent) with~~ the submission of the first Final Site Plan and provide a draft checklist showing how the project plans to achieve the certification and clearly indicate that requirements for Energy Use Reduction, Water Efficiency and Indoor Environmental Quality are being met as set forth above.\*
