


American Rescue Plan Act

City Council Public Hearing, June 19, 2021



Recommendation



That City Council:

(1) Hold a public hearing regarding the consideration of potential programs/projects for developing an ARPA spending plan, and

(2) Discuss prioritization of potential programs/projects for the first tranche to advise staff on the development of the ARPA Spending Plan

ARPA Overview



- On March 11, President Biden signed the \$1.9 trillion American Rescue Plan Act (ARPA),
 which established the Coronavirus State and Local Fiscal Recovery Fund.
- This fund provides \$130.2 billion to local governments nationwide for COVID-19 pandemic recovery assistance.
- The City will be allocated \$59.6 million
- These funds will be paid to localities in two equal allotments, the first already received and the second in May 2022
- The spending period is from March 3, 2021 to December 31, 2024 (45 months)
- ACPS will receive a separate allocation of \$35,407,000



ARPA Overview



The permitted use of the funds as stated in the law are proscribed and limited as follows:

- A. To respond to the public health emergency or its negative economic impacts, including assistance to households, small businesses, and nonprofits, or aid to impacted industries such as tourism, travel, and hospitality;
- B. To respond to workers performing essential work during the COVID-19 public health emergency by providing premium pay to eligible workers;
- C. For the provision of government services to the extent of the reduction in revenue due to the COVID–19 public health emergency relative to revenues collected in the most recent full fiscal year prior to the emergency; and
- D. To make necessary investments in water, sewer, or broadband infrastructure.



ARPA Update



Since the signing of this legislation and subsequent discussion at the March 27 City Council Legislative Session, there have been five new developments:

- 1. The U.S. Treasury Department released the Interim Final Rule on May 10, providing detailed guidance on the regulatory uses of the funds;
- 2. Virginia Independent Cities prevailed with the federal government recognizing the dual city and county roles of Virginia Cities, as was the Congressional intent, resulting in more than \$450 million allocated from the county list to the Virginia Cities, in addition to their city allocation.
- 3. On May 17, the U.S. Treasury transferred \$29.8 million to the City.
- 4. City staff collected community feedback on potential uses of the funds; and
- 5. Staff prepared proposals for projects and programs.



Interim Final Rule



- The Interim Final Rule provided greater detail and clarification on the legislation and its uses.
- Most notable included revenue loss and infrastructure.
 - Clarification on revenue loss:
 - Provides the greatest flexibility and would allow the City to fund services or projects that would not otherwise be considered eligible expenses.
 - OVID year (FY 2019) with an assumed rate of growth of 4.1% to determine the revenue that the City would have expected to collect if not for the economic impacts of the pandemic.
 - This calculated revenue estimate is compared to the actual revenue collected for the calendar year ending December 31, 2020. The difference is considered the City's revenue loss due to COVID.
 - The first period comparison as of December 31, 2020, shows lost revenue equal to about twothirds of the total ARPA allocation to the City.
 - Calculations are being double checked and will be independently verified.
 - ARPA revenue loss dollars can be used for nearly any authorized government purpose.



Interim Final Rule



- Clarification on Infrastructure:
 - A general infrastructure project typically would not be included unless the project responded to a specific pandemic public health need (e.g., investments in facilities for the delivery of vaccines) or a specific negative economic impact like those described above (e.g., affordable housing).
 - The ARPA explicitly includes infrastructure if it is "necessary" and in water, sewer, or broadband."
 - Water projects should ensure clean and safe drinking water and sewer projects should consider green infrastructure investments and projects to improve resilience to the effects of climate change
 - Eligible broadband projects are expected to be designed to deliver, upon project completion, service that reliably meets or exceeds symmetrical upload and download speeds of 100 Mbps and/or
 - Assistance to households facing negative economic impacts due to COVID-19 is also an eligible use, including internet access or digital literacy assistance.





- Between April 30 to May 13, the City sought feedback from the community on ARPA funding uses.
- The process included distribution of an online survey and two virtual public meetings.
- Staff directly reached out to community organizations, boards, and commissions, including the COVID-19 Community Response Group, to ensure their participation and assist with information distribution.
- Over 1,300 individuals responded to the survey and 60 participants in the virtual meetings
- Responses were shown to be broad, reflecting a diversity of interests.
- A full report on Community Feedback is posted on the City's website.

The survey included one open-ended question, allowing survey takers to provide their thoughts and ideas on how the funds should be used. The results were wide-ranging, covering topics that included:

Proposals Process



- Started with a list of potential programs and projects that have previously vetted through a community process
- Added to the list programs and projects that will address issues exacerbated by COVID-19
- Further developed and refined the list through community engagement
- As Treasury guidance was released, ensured proposals meet eligibility
- Human Services Recovery Team, CIP Steering Committee, and Economic Recovery Team scored proposals based on:
- 1) Feasibility, 2) Cost, 3) Community feedback, 4) Equity, 5) Any potential red flags
- Based on review, prioritized proposals within four quadrants

Proposals Process




- Tier 1&2 Projects and programs that will have the most immediate impact, are "shovel-ready," and highly important.
 - Count of projects: 18
 - Total amount of projects: \$28,663,360
- Tier 3&4 Projects and programs that are highly important but may not be as urgent or ready to address immediately (may make more sense for the 2nd tranche)
 - Count of projects: 31
 - Total amount of projects: \$29,136,785
- Beyond Tier 4 Projects that may not directly qualify for the intent of ARPA funds, may not be considered feasible within the timeframe, and/or should be considered through other funding sources.

The proposals do not show costs at this time because many of the proposals are scalable and can be adjusted based on City Council discussion and consideration of priorities. However, the projects do show cost by ranges.

Next Steps



- Staff will further develop the draft ARPA spending plan for the first tranche of funds.
- City Council will consider the plan for allocation of the first \$29.8million on July 6, 2021.
- Staff will develop the plan for the second \$29.8 million tranche in parallel with the FY23 budget and bring forward an allocation plan in the late fall. The second tranche plan will consider proposals that did not get funded in the first spending plan, in addition to new proposals, and will also need to sync with the FY23 budget process.
