ORAL REPORTS AND ORAL PRESENTATIONS BY MEMBERS OF CITY COUNCIL

- 1. Councilman Chapman reported that he and Mayor Wilson have been working on possible solutions to help residents with parking and parking capacity. Councilman Chapman requested that staff investigate what a pilot resident only parking program looks like and present Council with the pros and cons of such a program.
- 2. Councilman Seifeldein requested information from staff on adding an additional ACORP mental health expert to the pilot team for Council consideration at an upcoming meeting.
- 3. Councilwoman Jackson read a statement regarding School Resource Officers and the noted that she would like request reconsideration of this discussion to reallocate the money for SROs. Councilwoman Jackson responded to questions from Councilman Chapman about possible solutions for school safety options.

Councilman Aguirre gave an overview of events that led to the discussion that was happening this evening about SROs.

Vice Mayor Bennett-Parker gave a statement about the ongoing discussion and noted that a consensus was needed in order to move forward. Vice Mayor Bennett-Parker reviewed the plan as presented by four Councilmembers, including the following: a limited and temporary transitional period of police officers detailed to all high school and middle school campuses paid for by the City; the City would cover the cost of the off-duty officers employed by ACPS and would add additional funding for ACPS to expedite the hiring of the additional security guards as proposed by ACPS, until the end of the school year with a long term solution to take effect at the beginning of the 2022-2023 school year; provide additional funding and resources to support students including for restorative practices, to cover fees for vulnerable students to participate in afterschool activities and a renewed focus on mentoring; a review of the school security contract that ACPS uses for the security officers for the system; the creation of an open and transparent data portal for the public to access data on school security and safety; and beginning with the 2022-2023 school year, School Safety Coaches, following the model established by Charlottesville, Virginia[1] would be inside our secondary school

WHEREUPON, upon motion by Councilwoman Jackson, seconded by Councilwoman Pepper, to direct the City Manager to look into funding for five officers with a comparable solution for five on-duty and five off-duty officers including overtime cost. This motion was withdrawn.

A motion was made by Councilman Aguirre, seconded by Councilman Seifeldein, to direct staff to investigate the feasibility of the options offered in the memo from the members of

Council and including funding sources for the items. This motion was withdrawn.

WHEREUPON, upon motion by Councilman Chapman, seconded by Councilwoman Jackson and carried 4-3, City Council moved the following:

- 1) A transitional detail of SROs to all high school and middle school campuses, which would restore the current SRO program under the revised MOU that is currently in place. The end of the transition would correlate with the hiring and training of school safety coaches to replace the SROs in the schools. The City would also cover the cost of the off-duty officers employed by ACPS and would add additional funding for ACPS to expedite the hiring of the additional security guards proposed by ACPS. This is the proposed plan through the end of the school year, with a new long-term solution (School Safety Coaches) taking effect at the beginning of the 2022-2023 school year.
- 2) Funding and additional resources to support students, including for restorative practices; covering fees for vulnerable students to participate in afterschool activities, and a renewed focus on mentoring.
- 3) Funding to support teachers, including for optional training in de-escalation
- 4) An Immediate Review of the over \$1 Million School Security Contract that ACPS uses to hire more than 40 security officers at ACHS.
- 5) A Transparent Open Data Portal. We ask ACPS to create and maintain publicly accessible data, as allowable by law, on incidents involving violence and involving law enforcement, including previous years.
- 6) Beginning with the 2022-2023 school year, School Safety Coaches, following the model established by Charlottesville, Virginia[1] would be inside our secondary schools. The School Safety Coaches would be funded by the City, in addition to the mental health positions and resources previously defined and allocated earlier this year.

The funding source for these requests will come from funding from money left over from FY2021.
