
1	ORDINANCE NO
2	AN ORDINANCE to amend and reordain the Master Plan of the City of Alexandria, Virginia, by
4	adopting and incorporating therein the amendment heretofore approved by city council to
5	the Beauregard Small Area Plan chapter of such master plan as Master Plan Amendment No.
6	2021-00006 and no other amendments, and to repeal all provisions of the said master plan as
7	may be inconsistent with such amendment.

9	WHEREAS, the City Council of the City of Alexandria finds and determines that:
10	
11	1. In Master Plan Amendment No. 2021-00006, the Planning Commission, having
12	found that the public necessity, convenience, general welfare and good zoning practice so
13	require, recommended approval to the City Council on October 5, 2021 of an amendment to the
14 15	Beauregard Small Area Plan Chapter of the Master Plan of the City of Alexandria to amend the proposed land uses figure, which recommendation was approved by the City Council at public
16	hearing on October 16, 2021;

18	2. The said amendment has heretofore been approved by the planning commission
19	and city council after full opportunity for comment and public hearing.

21	3. All requirements of law precedent to the adoption of this ordinance have been
22	complied with; now, therefore,
23	
24	THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:
25 26	Section 1. That the Beauregard Small Area Plan Chapter of the Master Plan of the
27	City of Alexandria, be, and the same hereby is, amended by amending Figure 25: Proposed Land
28	Uses to change the land use designation for: (1) a portion of 5000 Seminary Road to include
29	residential, commercial, office, and continuum of care facility uses in addition to hotel uses;
30	and (2) 4880 Mark Center Drive to include hotel and continuum of care facility uses in addition
31	to residential, commercial and office, attached hereto and incorporated fully herein by reference,
32	as a new chapter of the Master Plan of the City of Alexandria, Virginia.
33	
34	Section 2. That the director of planning and zoning be, and hereby is, directed to
35	record the foregoing master plan amendment as part of the Master Plan of the City of
36	Alexandria, Virginia.
37 38	Section 3. That all provisions of the Master Plan of the City of Alexandria, Virginia,
39	as may be inconsistent with the provisions of this ordinance be, and same hereby are, repealed.

41	Section 4. That the Master Plan of the City of Alexandria, as amended by this
42	ordinance, be, and the same hereby is, reordained as the Master Plan of the City of Alexandria,

That the city clerk shall transmit a duly certified copy of this ordinance to the Clerk of the Circuit Court of the City of Alexandria, Virginia, and that the said Clerk of the Circuit Court shall file same among the court records. Section 6.
