[26-0941](#) Second Reading and Final Passage of an Ordinance to amend and reordain Section 5-8-93 (PARKING METERS; HOURS AND DAYS OF OPERATION; MAXIMUM TIME LIMITS; RATES) of Article G (PARKING METERS) of Chapter 8 (PARKING AND TRAFFIC REGULATIONS) of Title 5 (TRANSPORTATION AND ENVIRONMENTAL SERVICES) of the Code of the City of Alexandria, Virginia, 1981, as amended. [ROLL-CALL VOTE]

*City Council moved to disapprove the ordinance to add Sunday parking meters operations.*

3. [26-0938](#) Second Reading and Final Passage of an Ordinance on the Proposed Real and Personal Property Tax Rates and Proposed Effective Tax Rate Increase for Calendar Year 2026 (Fiscal Year 2027). [ROLL-CALL VOTE]

*City Council adopted an ordinance to set the City's calendar year 2026 blended real property tax rate at one dollar and thirteen and one half cents (\$1.135) on each \$100 of assessed value. The rate reflects no change from calendar year 2025. The calendar year 2026 real property tax rate contains the following:*

*\*The sum of two point two cents (\$0.022) on each \$100 of assessed value of the one dollar and thirteen and one half cents real property tax rate will be collected and*

reserved for the Transportation Improvement Fund.

\*The sum of one cent (\$0.01) on each \$100 of assessed value of the one dollar and thirteen and one half cents real property tax rate will be dedicated for affordable housing purposes beginning on July 1, 2026.

\*The sum of twenty cents (\$0.20) on each \$100 of assessed value to be levied on all real property located in the Tier 1 Potomac Yard Metrorail Station Special Services District. This rate remains unchanged from calendar year 2025.

The total blended real property tax rate for the City in calendar year 2026 will be one dollar and thirteen and one half cents (\$1.135).

The calendar year 2026 personal property tax rates contain the following:

\*The sum of five dollars and thirty-three cents (\$5.33) on each one hundred dollars of assessed value of vehicle personal property. The rate remains unchanged from calendar year 2025.

\*The sum of four dollars and seventy-five cents (\$4.75) on each \$100 of assessed value of tangible business personal property. This rate remains unchanged from calendar year 2025.

\*The sum of four dollars and fifty cents (\$4.50) on each \$100 of assessed value on all automobiles, trucks, trailers, and semi-trailers with a gross vehicle weight of 10,000 pounds or more which are used to transport property for hire by a motor carrier engaged in interstate commerce and are owned or held by residents or citizens of the city. This rate remains unchanged from calendar year 2025.

\*The sum of three dollars and fifty five cents (\$3.55) of each 100 of assessed value on all automobiles and trucks which are equipped with specially designed equipment for use by the handicapped and are owned or held by residents or citizens of the city. This rate remains unchanged from calendar year 2025.

\*The sum of one cent (\$0.01) on each \$100 of assessed value to be levied on all privately owned pleasure boats and watercraft, which are used for recreational purposed only, and are owned or held by residents or citizens of the city. This rate remains unchanged from calendar year 2025.

\*The sum of one dollar and thirteen and one half cents (\$1.135) on each \$100 of assessed value to be levied on mobile homes. This rate remains unchanged from calendar year 2025. (ORD. NO. 5629)

*City Council adopted the budget resolution which includes an annual General Fund operating budget for FY 2027 of nine hundred seventy-nine million, sixty-three thousand, six hundred and eighty-one dollars (\$979,063,681); and the FY 2027 to FY2036 Capital Improvement Program of two billion, twenty million, two hundred and seventeen thousand, three hundred and sixty-eight dollars (\$2,020,217,368) in total; including two hundred and forty-four million, five hundred and fifty-six thousand, seven hundred and eight dollars (\$244,556,708) in total for FY 2027. (RES. NO. 3381)*
