ORAL REPORTS BY MEMBERS OF CITY COUNCIL

ORAL PRESENTATIONS BY MEMBERS OF CITY COUNCIL

- 1. Mayor Euille said that on Friday night at 6:00 p.m. will be the official Christmas Tree lighting at Market Square and he encouraged everyone to come out for the lighting. He encouraged everyone to enjoy the Old Town King Street corridor restaurants and retail shops.
- 2. Mayor Euille said that preceding the Friday night Christmas Tree lighting is Black Friday, November 29, and all the City public parking garages will be free and open to the public.
- 3. Mayor Euille said that Saturday, November 30 has been set aside by the President of the United States as National Small Business Saturday, which is a day for people to shop at small businesses across America.
- 4. Mayor Euille said the Metro Office on Bus Planning is inviting citizens and riders to participate in a focus group meeting designated to gather input on the development of Metro's bus service design guidelines. The first meeting will take place on Wednesday, December 4, from 4:30 to 6:30 p.m. at the Martin Luther King, Jr. Memorial Library in Washington, D.C.
- 5. Councilmember Lovain said the Transportation Commission held a retreat on November 15, and one of the upshots of it was a decision for the Commission to undertake a five-year review of the Transportation Master Plan.
- 6. Councilmember Lovain said he continues to miss Ron Kirby and it was a very moving funeral and he will be sorely missed. He said that COG appointed a couple of long time staffers, Gerald Miller and Robert Griffiths to serve as acting co-directors of Transportation Planning, and the Regional Transportation Priorities Plan has been postponed because of Mr. Kirby's death. Councilmember Lovain said that the last thing Mr. Kirby did was his final edits on that revised plan. It will now come before the Transportation Planning Board in December for review and in January for final approval.
- 7. Councilmember Lovain said that anyone interested in the Children Youth Master Plan or in the School search for a new Superintendent and the criteria they should be looking for are both looking for public comments.
- 8. Vice Mayor Silberberg noted her good wishes to everyone for a wonderful and Happy Thanksgiving. Vice Mayor Silberberg said there are a number of events coming up in the City over the next few weeks and she hoped everyone could participate.
- 9. Vice Mayor Silberberg said they are experiencing rain in the City and she asked Deputy City Manager Evans to speak to the issues at Beatley Central Library, which has had leakages and problems.
- 10. Councilman Chapman said American Express and a couple other small businesses are partnering with small businesses this year to promote the focus on shopping local and shopping small businesses. With Old Town being one of the big hubs, it will be evident on Saturday when a number of businesses will have banners and balloons and it will be a huge effort to focus on the benefit that local citizens can have to their neighborhood businesses by shopping local.
- 11. Councilman Chapman said he had the opportunity with Vice Mayor Silberberg

and Councilwoman Pepper to attend the volunteer party for the Archaeological Friends of Archaeology. He said it was a large group of folks who volunteer every year for the City at different digs, and it is a testiment to the citizens that care enough about the City's history to get involved.

12. Councilman Chapman said they had a Design Review Board meeting for Carlyle this past week. One of the things they looked at was a reprogramming of one of the buildings that will be built. As they start to have more infill in the Carlyle area, especially with the National Science Foundation coming on board, they will see the different aspects of different buildings, whether it is commercial or residenital, and what that make-up is shift based on the market.
