ORAL REPORTS BY MEMBERS OF CITY COUNCIL

ORAL PRESENTATIONS BY MEMBERS OF CITY COUNCIL

- 1. Councilman Smedberg said he participated in a transportation roundtable with Senator Kaine that was hosted by the NVTC. He said Senator Kaine wanted to hear from the people in the room about their transportation and transit priorities and concerns and they spoke to funding. He said it was a very lively and good discussion.
- 2. Mayor Euille said that earlier this evening, Council witnessed the presentations of the annual awards by the Commission on Aging, and Councilwoman Pepper received the Annie B. Rose Lifetime Achievement Award for excellence in aging. Anastasia Graham received the Lois Van Valkenberg Excellence in Aging award for an individual, the Excellence in Aging award for an organization went to Alexandria Yellow Cab, and the Excellence in Aging award for public service went to the director of the Division of Aging and Adult Services Mary Ann Griffith.
- 3. Mayor Euille noted that congratulations go to the first two women in the Alexandria Police Department who were recently promoted to Deputy Chief Tammy Hooper and Diane Gittins.
- 4. Mayor Euille said that Metro has finally put the finishing touches on the FY2015 operating and CIP budgets, the operating is \$1.7 billion and the CIP is \$1.2 billion. The budget includes a new fare structure that will increase the average cost of a subway ride by \$.10 to \$3.00, the \$1.2 billion in CIP improvements for 2015 is a first down payment on a 10-year CIP that is part of the strategic plan process. Riders will see 64 new rail cars out of 740 new rail cars that are on order. It will also buy 101 new low-floor buses for Metro Access shuttle service.
- 5. Mayor Euille showed a photo of Union Station in Bristow, Virginia noting that it is lit up with lights and upgraded, and he said how he hoped the City would better utilize the train station the City owns to include using it for weddings, meetings and receptions.
- 6. Councilmember Lovain said he gave the City's testimony before the Commonwealth Transportation Board on April 24, and it was a pleasant meeting because the money is flowing from the State. He said he spoke about the Transportation Planning Board and its effort with COG to improve the accessibility of bus stops in the region and also the work of the TPB to update the human services transportation plan and begin another round of grant funding. That effort is underway with both the committees he chairs for the TPB, and they are meeting again tomorrow.
- 7. Councilman Wilson said that in approving the budget, Council modified the City Manager's recommendations as it relates to movement of fire engine 204 to station 210 and there was varying opinions on Council about what the next steps would be. He said his preference was to look again at applying for a SAFER grant and possibly staffing that engine at 210 in the FY2016 budget. There will be decisions that have to be made by Council in advance of the 2016 budget process. He spoke to budget memo #37, which noted that Council would need to add additional positions in future fiscal years to staff an engine at 210. He said his question to the City Manager is that

he bring back a menu of options for Council to discuss this fall about what they would like to do with fire station 210 in the future.

8. Councilman Chapman said that this last week he attended the Human Services Public Safety Committee meeting for COG and their discussion centered on homelessness, specifically Veteran homelessness. One of the things he took away from the meeting was the City's plan on homelessness, as it has a 10-year plan to end homelessness, and their 10 years runs out in 2014. He said he has been speaking with staff about how Council sunsets what it has done and hopefully take a look back over the 10 years as well as start to craft what it wants to do in the future to be able to have that plan ready and put it into action in 2015.
